March 2, 2021

Public comments were accepted via eComment, email, by phone and webinar.

The Council meeting was teleconferenced from remote locations.

classification with a salary range of \$98,862.40 - \$121,742.40 to a new salary range of \$103,000 - \$133,900 annually;
(b) Retitle the Program Manager I (8073) classification to Program Manager (8073); and
(c) Delete the Program Manager II (8076) classification.

Report on bids and award of construction contract for the 9664 - East San José Bikeways - Signs and Sharrows Project to the low bidder, Crisp Company, in the amount of \$527,774, and approval of a 10 percent contingency in the amount of \$52,777.

CEQA: Categorically Exempt, File No. PP18-029, CEQA Guidelines Section 15301(c), Existing Facilities. Council District 5. (Public Works/Transportation)

Mayor Sam Liccardo pulled the item for specific details, and Director of Department of Transportation, John Ristow responded to questions.

Public Comments: (1) Blair Beekman spoke to related technology issues. (2) Paul Soto complained that city is simply addressing ‘data points’ and not real needs of the public accessing services.

Action: The report on bids and award of construction contract for the San Jose Bikeways Project with related contingency was approved. (10-0-1. Absent: Carrasco.)

2.9 21-383 Fiscal Year 2020 Traffic Impact Fee Report.

Accept the annual and five-year report prepared in accordance with the Mitigation Fee Act (Government Code section 66000 et seq.) on the status of the City’s four traffic impact fee programs: North San José, Evergreen-East Hills, US-101/Oakland/Mabury, and Interstate 280/Winchester Boulevard.

Mayor Sam Liccardo posed questions regarding traffic impact fee reports. Director of Department of Transportation, John Ristow responded to inquiries on and offered to look into a process to make it easier for the development community to calculate VTA calculations, geographical/location aids.

Public Comments: Paul Soto asked for more analysis being done on construction contracts and spoke on justification for so much money allocated to the construction industry.

Action: The Fiscal Year 2020 Traffic Impact Fee Report was accepted. (10-0-1. Absent: Carrasco.)

2.10 21-429 **Amendments to Title 27 of the San José Municipal Code Related to the Procurement of Public Works. - RENUMBERED FROM ITEM 3.3**

Approve an ordinance that continues the process of modernizing, streamlining, and clarifying the public works contracting process by amending certain chapters and sections of Title 27 of the San José Municipal Code as follows:

- (a) Amending Sections 27.04.100, 27.06.070, and 27.10.560 to make the threshold amounts for micro contracts and for the Director to award certain public works contracts subject the inflation adjustment process already in Title 27;
- (b) Amending Section 27.06.060 to expand the required expiration date of the prequalified contractor pools used for the competitive work order procurement process from 12 months to 24 months;
- (c) Amending Section 27.06.070 to add another basis for determining the award of on-call contracts to reflect current practice;
- (d) Amending Chapters 27.26 and 27.28 to modify certain compensation and dispute resolution provisions to accommodate updates to 29-year-old standard construction contract provisions relating to delay, claims and compensation; and
- (e) Amending Section 27.50.020 to clarify certain reporting requirements to better support open and transparent government practices.

City Manager, David Sykes applauded unsung heroes, the Police Communications Control Room personnel, noting in particular hurdles overcome while providing service during the pandemic.

Deputy City Manager, Kip Harkness and Deputy Director of Finance, Jennifer Chang, Intergovernmental Relations, provided a COVID-19 update. Providing a strategic communications plan recap relating to the pandemic and quantitative data were Director of Communications, CMO’s Office, Carolina Camarena, and DOT Public Information Manager Colin Heyne.

Public Comments: (1) Soto asked that Office of Racial Equity be used in allocation of funds. (2) Michelle spoke to ableism and need to include those with disabilities and measure of equity. (3) Molly Macleod spoke to needs of those culturally marginalized and functionally challenged, presented disability advocacy and the need for ASL interpretation. (4) Blair Beekman advised Study sessions around human rights and accountability and large scale social planning. (5) Sherry Burns urged vaccine centers must be accessible by bus and paratransit. (6) Brian Darby offered appreciation for the efforts expended.

Staff responded to needs of members of the community with disabilities and additional questions from Council.

Adopt a resolution finding the continued existence of a local emergency and extending the March 6, 2020 Director of Emergency Services' proclamation of a local emergency resulting from community spread of the coronavirus, also known as COVID-19, in the City of San José.
CEQA: Statutorily Exempt, CEQA Guidelines Section 15269, Emergency Projects Undertaken for Specific Actions Necessary to Prevent or Mitigate an Emergency. (City Manager)
Heard Concurrently with Item 3.5

Director of the Office of Emergency Management, Ray Riordan introduced the topic, and discussion ensued.

Action: Upon motion by Councilmember Dev Davis, seconded by Councilmember Maya Esparza and carried unanimously, **Resolution No. 79912** extending the Proclamation of Local Emergency Related to COVID-19 was adopted. (11-0.)

**3.5 21-386 COVID-19 Preliminary Operational Assessment Report.

Accept the 2020 COVID-19 Preliminary Operational Assessment Report, Operational Adjustment Plan, and white papers.
CEQA: Not a Project, File No. PP17-010, City Organizational and Administrative Activities resulting in no changes to the physical environment. (City Manager)

Jason Ferguson, Senior Associate, Constant Associates spoke on the process.

Public Comments: (1) Paul Soto referenced racial equity and how this lens can alleviate suffering in the City. (2) Katherine Hedges expressed the need for the disability community to be included, and cited rampant ableism. (3) Molly Macleod urged the need for an office of disability affairs and thanked Kip Harkness for his acknowledgement that more work needs to be done. (4) Michelle Ashburne spoke on the struggle of the disabled and the need for their access to vaccine and testing sites. (5) Blair Beekman spoke to additional needs of community and natural disaster preparation. (6) Sherry Burns addressed needs with access and functional shortcomings.

Council discussion followed, and staff spoke to including information as it relates to race and equity and disproportionate impacts on hard-to-reach populations, and with an additional focus on a disability component; exploring broadening scope of MOU's regarding economic impacts on and violence against women and young girls as brought forth by Council to be incorporated into a report due within 30-45 days.

Action: On a call for the question, the motion carried unanimously to move forward with recommendations in the report in view of the budget cycle, with revisions to be provided by staff within 30-45 days and to include information as it relates to race and equity and disproportionate impacts on hard-to-reach populations, and with an additional focus on a disability component; exploring broadening scope of MOU's regarding economic impacts on and violence against women and young girls. 7.1 21-387 Parkland Fee Credits for Deed Restricted Moderate-Income Housing Units.

(a) Approve an ordinance amending Chapter 14.25 of Title 14 and Chapter 19.38 of Title 19 of the San José Municipal Code ("SJMC") prescribing new definitions for moderate-income units, gross household income for moderate-income units, and expanding affordability restrictions to include moderate-income units, and to provide that moderate-income units shall pay fees set forth in the schedule of parkland fees.

(b) Adopt a resolution amending Resolution No. 78474 (Schedule of Parkland Fees) temporarily establishing the parkland fees charged pursuant to Chapters 14.25 and 19.38 of the SJMC be set at 50% of the applicable parkland fees for deed restricted moderate-income residential units that are provided to satisfy Inclusionary Housing ordinance provisions (SJMC Chapter 5.08) until January 1, 2026.

CEQA: Not a Project, File No. PP17-005 Adjustment to Fees, Rates and Fares without changes to or expansion of services. (Parks, Recreation and Neighborhood Services)

Deputy Director of Parks, Recreation and Neighborhood Services, Nicolle Burnham and Rebecca Ross Supervising Planner, PRNS provided a presentation.

Public Comments: (1) Paul Soto provided criticism, noting that redlined areas have no parks built in them. (2) Task Force member, Pat Saucedo encouraged support. (3) Matthew Reed, SV@Home offered support, clarifying that it is an extension of the current policy. (4) Kathryn Hedges recommended incentivizing more affordable housing without seeing red-lined communities deprived. (5) Tim Beaubien (Santa Clara County Association of Realtors) noted support, citing need for more affordable housing. (6) Roland LeBrun recommended thinking in another dimension, for example having parks on top of buildings, using San Francisco as an example. (7) Lillian, a resident of D6, asked that space not be reduced.

Mayor Sam Liccardo left the meeting for a previous engagement, and Vice Mayor Chappie Jones continued to chair the meeting.

Councilmember Pam Foley asked for clarification from City Attorney, Nora Frimann before making a motion.

Motion: Councilmember Pam Foley moved acceptance of the Staff recommendation with the additional direction as outlined in the memorandum she coauthored with Councilmembers Cohen and Jimenez, dated February 26, 2021. Councilmember David Cohen seconded the motion.

Action: **Ordinance No. 30541** amending Chapter 14.25 of Title 14 and Chapter 19.38 of Title 19 of the San José Municipal Code was passed for publication; and **Resolution No. 79913** amending Resolution No. 78474 (Schedule of Parkland Fees) was adopted, with staff recommendations, including the joint memorandum from Councilmembers Foley, Cohen and Jimenez, dated February 26, 2021, to:

1. Provide an annual cost/benefit analysis report to the City Council that includes the financial impact on parkland fees to PRNS as well as the number of affordable units constructed;
2. Align the expiration date of the Parkland Fee Credit program with the completion of a new nexus study which is expected to be completed in 2024;
3. Direct staff to include a study of Commercial linkage fee in the scope of the PRNS nexus study work;
4. Direct staff to pursue all avenues for new revenue sources in order to continue to invest in our parks and public spaces.

8.1 21-388 Actions Related to the Purchase and Sale of Properties Located at North 13th Street and East Santa Clara Street.

(a) Adopt a resolution authorizing the City Manager to:

(1) Negotiate and execute a Purchase and Sale Agreement, and all other documents necessary to effectuate the property transfer between the City of San José and the Valley Transportation Authority (VTA), for the sale of the properties known as 575-579 East Santa Clara Street, identified as Assessor's Parcel Numbers 467-16-091 and 467-16-092, in the amount of \$2,500,000;

(2) Declare the 575-579 East Santa Clara property (APNs 467-16-091 and 467-16-092) as "exempt surplus land" to the needs of the City pursuant to Cal. Gov. Code §54221(f)(1)(D), San José Municipal Code Section 4.20.080 and in accordance with Council Policy 7-13(D)(3);

(3) Negotiate and execute a Cooperation and Reimbursement Agreement between the City of San José and the VTA to offset additional environmental remediation, mitigation, and construction costs for the City's use of the Option Property, in the amount of \$300,000; and

(4) Exercise the Option to Purchase Agreement between the City of San José and the Santa Clara County Housing Authority dated August 24, 2020, for the purchase of the property located at 601 East Santa Clara Street, identified as Assessor's Parcel Number 467-15-010, in the amount of \$2,194,200.

(b) Adopt the following 2020-2021 Appropriation Ordinance and Funding Sources Resolution amendments in the Public Safety and Infrastructure Bond Fund:

(1) Establish the Other Revenue appropriation in the amount of \$2,500,000;

(2) Establish the Revenue from Local Agencies in the amount of \$300,000; and

(3) Increase the Measure T - Fire Station 8 Relocation appropriation to the Public Works Department by \$2,800,000.

CEQA: Not a Project, File No. PP17-003, Agreements/Contracts (New or Amended) resulting in no physical changes to the environment.

Council District 3. (Economic Development/Public Works/Fire/City Manager)

Aaron Freyler, Deputy Chief, Fire Department and Kevin Ice, Senior Manager, Real Estate Services provided a presentation.

Public Comments: (1) Paul Soto recommended leasing the land rather than selling it. (2) Roland Offered support but offered criticism of the first responders response times.

Director of Public Works, Matt Cano responded to questions.

Action: Upon motion by Councilmember Raul Peralez, seconded by Councilmember Dev Davis and carried unanimously, (a) **Resolution No. 79914** regarding actions Related to the Purchase and Sale of Properties Located at North 13th Street and East Santa Clara Street, and (b) Appropriation **Ordinance No. 30542** and Funding Sources **Resolution No. 79915** regarding amendments in the Public Safety and Infrastructure Bond Fund were adopted. (11-0.)

8.2 21-394 City's COVID-19 Response: Emergency Rental Assistance Program. - RECOMMEND DEFERRAL

(a) Accept the staff report on the Emergency Rental Assistance program.

(b) Adopt a resolution:

(1) Accepting \$30,379,739.90 in Emergency Rental Assistance funds from the U.S. Department of the Treasury and ratifying the City Manager's signing of the award terms;

(2) Authorizing the City Manager to negotiate and execute the following grant agreements, including any amendments and revisions to said agreements and any necessary documents to effectuate the grant, to use Emergency Rental Assistance Funds to provide assistance to San José tenants and landlords who have been negatively impacted by the COVID-19 pandemic:

(i) With Destination: Home, a supporting organization of Silicon Valley Community Foundation, in an amount not to exceed \$__ million to provide rental assistance, utility relief, and other eligible housing assistance to San José residents, as well as to fund case management and outreach efforts to connect San José residents with rental assistance, utility relief, and other housing assistance.

(c) Adopt the following Funding Sources Resolution and Appropriation Ordinance amendments in the Emergency Reserve Fund:

(1) Increase the estimate for Revenue from Federal Government by \$30,379,740; and (2) Establish the Emergency Rental Assistance appropriation to the City Manager's Office in the amount of \$30,379,740.

CEQA: Statutorily Exempt, CEQA Guidelines Section 15269, Emergency Projects Undertaken for Specific Actions Necessary to Prevent or Mitigate an Emergency. (Planning, Building and Code Enforcement/City Manager)

Public Comments: (1) Paul Soto challenged structural racism. (2) Speaker "5140" spoke against vaccines.

Action: Upon motion by Councilmember Pam Foley, seconded by Councilmember Maya Esparza and carried unanimously, **Resolution No. 79916** regarding Ratification of the Declaration Suspending Enforcement of Certain Provisions in Land Use Permits and Zoning Approvals was adopted. (11-0.)

OPEN FORUM

1. Paul Soto thanked ‘the Chicano 5’ for their input. He spoke on his advocacy in promoting well-being in the community, and complained about rhetoric that is doing nothing to lessen the suffering of marginalized communities.
2. Roland Lebrun spoke on the project at North 13th Street and East Santa Clara Street, offering a comparison to a similar San Francisco project, asking the City to consider a building that spans both sides of street.
3. Blair Beekman expressed views on the future of an eviction moratorium, natural disaster preparedness, and issues of equity, urging sensitivity when working on these issues.
4. Christine Fitzgerald, Human Services Commission, emphasized advocacy for vaccinating the disabled population. She urged creation of a dedicated commission for people and represented by people with disabilities.
5. Sam Nazzal noted that the City is requiring demolition of his carport at the urging of a neighbor, and asked for an extension or variance.

Mayor Sam Liccardo indicated to speaker that this body has no mechanism for granting variances. He was asked to remain on the line after this meeting, and his information would be forwarded to appropriate personnel.

6. Speaker “5140” complained of bike lane planning and slow response time for fire emergencies.
7. Lillian, District 6, advocated for pop-up sites for COVID vaccines. With March being Women’s History Month, she urged addressing the issue of violence against women.
