

Guadalupe Gardens - To Date

- Re-housed 54 people, ~90-100 people remain
- Removed 1 million pounds of debris
- Prevented re-encampment of Stages 1 and 2
- Closed Spring St. at Hedding
- Provided 28 porta-potties for unhoused residents
- Repaired water access for unhoused residents at Columbus Park
- Provide weekly trash pick-up
- Installed No Illegal Dumping Signs and Camera Set

Housing - Next

- Coordination with County Office of Supportive Housing for priority housing placements
- Implement safe parking program, prioritize Hedding/Spring vehicles
- Mobile mechanic/vehicle repairs
- Implement SJ Bridge housing and employment program
- Consider timelines of clearing Stage 3 to align with more shelter and housing

Trail Vehicle Prevention Project - Now


Unauthorized vehicle use of Guadalupe River Trail

Bicyclists and pedestrian concerns

Environmentally harmful to riparian corridor

Barriers present at design have been removed

Resilience Corps conducting ongoing trail management



Trail Vehicle Prevention Project - Next

- Hedding Street to Coleman Avenue
- Remove inoperable and operable vehicles from trail
- Install deterrents to prevent vehicle intrusion while protecting cyclist safety
- Consider funding for design and installation of bollards and K-rail

Goals

Recommended Actions

- a) Accept the report on Guadalupe Gardens Fencing & Activation Alternatives including protective and activation measures and authorize the City Manager to:
 - 1) Receive feedback on the Prototype Park Concept Plan and Vehicle Prevention Project; and
 - Identify ongoing operating, programming and stewardship costs needed to implement the Prototype Park Concept Plan with the Guadalupe River Park Conservancy or through a Request for Proposals process.
- b) Adopt a resolution authorizing the Director of Public Works to:
 - 1) Award and execute a contract for the construction of the 9821 Guadalupe Gardens Fencing Project, to the lowest responsive, responsible bidder in an amount not to exceed \$1,500,000;
 - i. In the event, that not all the \$1,500,000 is utilized, reallocate any remaining funding for protecting the land and other mitigation solutions to secure the space;
 - 2) Decide any timely bid protest(s) and make the City's final determination as to the lowest responsive bidder that is responsible as needed to award the contract; and
 - 3) Establish a construction contingency of up to 10% percent of the amount of the construction contract for the Project
