BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Lunar New Year Celebration was held on Saturday, February 12, 2022 at Eastridge Mall and sponsored by Councilmember Arenas. This special event was hosted by Eastridge Mall celebrating the Lunar New Year with our diverse communities with cultural performances, resource tables, and more. The event was free and open to the public.

ANALYSIS
