I have not previously served on any city or county boards or commissions. I did serve on the Civil Grand Jury in 2021, which is somewhat related (in the sense of understanding the roles of various county boards and special districts, and reviewing minutes/recordings/reports from various boards).

I gained some exposure to state and county required campaign financing disclosures during my work on the Civil Grand Jury. I can't claim any expertise in election law, but I feel that I understand the basics of it. More broadly, I found that my skills in data analysis proved useful in Civil Grand Jury work and I expect there could be similar utility on the FCPP commission.		
What is your understanding of the purpose of the Commission?		
I understand the Commission serves to review or adjudicate allegations of campaign finance and lobbying or ethics violations, as well as to make recommendations to the city council for refinements and changes to the existing regulations.		
Please list three issues facing the City that you feel the Commission should address.		
My understanding is that the FCPP commission primarily investigates complaints, rather than working on an agenda of specific issues. I have not researched a list of top 3 issues in the area of campaign finance, but I expect that there is likely room for improving the public accessibility and transparency of campaign financing around elections, as well as lobbying disclosures and related non-election information.
