SUBJECT: APPROVAL OF THE SAN JOSE STATE UNIVERSITY DESIGNING FORWARD EVENT SPONSORED BY COUNCIL DISTRICT 3 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

1. Approve the San Jose State University (SJSU) Designing Forward event scheduled on Thursday, May 19, 2022 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the May 10, 2022 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The SJSU Designing Forward event will be held on Thursday, May 19, 2022 in the City Hall Rotunda and is sponsored by Councilmember Raul Peralez. This special event will showcase designs and innovative projects produced by SJSU Industrial Design students. The exhibit will feature prototypes and creative solutions that aim to help solve issues in the community. This event will bring together students, faculty, industry professionals and members of the

community to engage with SJSU students and view their semester-long projects. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Raul Peralez will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 3, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
