BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The D. J. Meyer Elementary Egg Hunt and Resource Fair was held on Saturday, April 16, 2022 at D. J. Meyer Elementary School and sponsored by Councilmember Arenas. This special event supported families and provided resources to the community in a safe, fun, and festive manner. The event was free and open to the public and followed all appropriate local public health rules, including requiring masks and social distancing.
