As an adult I have raised a family here and have been active in the community. I have coached football, baseball, soccer, wrestling, and softball at the youth and high school levels. I never lost the passion for cars during this time. Once my kids finished school I had extra time and decided to help form the United Lowrider Council of San José which I am currently president of. Personally me, a Chicano man, was profiled in 2009 while driving my lowered Chevy Silverado as a 17 year old in high school. I inherited the truck from my dad because that's all we could afford, and was simply dropping off my friend downtown after a night at the drive-ins. It was clear my truck was a lowrider, I was wearing a poncho, and I had a sarape draped over the front bench seat. The female officer pulled me over, told me to get out and frisked me. She asked if I had weapons or if I was in a gang before even explaining what I did wrong. Once she realized she didn't have anything on me, she adopted a more friendly tone and explained that I committed a minor traffic violation, an allegation that didn't match the treatment of being frisked. She said I stopped at a stop sign, but proceeded through the intersection without looking and was almost t-boned by a car. This was a lie. There was no car going through, and it was clear that she used my truck and appearance as a pretext for pulling me over.

Furthermore, the culture of cruising aligns with the city's Vision Zero goals towards slower and safer streets. Today, traffic violence is the leading killer in the City of San José, with almost 2x as many traffic deaths as homicides and speeding is the leading reason based on DOT's analysis. Studies have also shown that as SUVs and cars are made bigger and taller, they kill more frequently because the impact gets closer to important organs and the head. Low and slow is the way we need to go. I request that you approve Councilmember Peralez's memo and that the City removes this unnecessary and offensive prohibition on cruising as soon as possible.
