RECOMMENDATION

- (a) Approve award of a construction contract for the 2022 Local Streets Microsurfacing Project, to the lowest bidder, VSS International, Inc., in the amount of \$3,970,120.
- (b) Approve an approximate 10% contingency in the amount of \$397,000.

OUTCOME

Approval of this contract will provide preventive maintenance on approximately 55 miles of streets on the Local and Neighborhood Streets Network in the 2022 construction season.

Approval of an approximate 10% contingency will provide funding for any unanticipated work necessary for the proper construction and completion of the project.

BACKGROUND

The Department of Transportation (DOT) is planning to seal (microsurface) approximately 55 miles of citywide streets out of the approximately 190 miles on the Local and Neighborhood Street Network in the 2022 construction season as a preventive maintenance measure to extend their useful life and reduce long-term maintenance costs to the City.

Preventive maintenance is performed in two separate phases: preparation and a final surface sealing application. The preparation phase includes Americans with Disabilities Act (ADA) curb ramp installations and retrofits. Streets to be surface sealed will also require the removal and replacement of any structurally failed areas of pavement. Microsurfacing is the surface-sealing treatment and involves the application of a thin layer of asphalt emulsion blended with rock approximately 3/8 an inch in depth to the pavement.

To decrease the overall timeframe for completing the preparation work, DOT is managing multiple projects for concrete and ADA curb ramp improvements most of which are in the

construction phase and one project for the removal and replacement of failed asphalt pavement areas where required. This project will apply the final surface application to seal the surface.

The City of San José's (City) Local and Neighborhood Street Network is organized into 135 geographically contiguous "Pavement Maintenance Zones" (PMZs). The PMZs were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic equity of pavement maintenance across San José. Information provided by the City's pavement management database is used to identify candidate PMZs for preventive maintenance and sealing. The final list of PMZs to receive treatments was established using the following criteria:

- Funding availability and funding use restrictions
- Streets on the Local and Neighborhood Street Network
- Streets not affected by current or future street related projects
- Maintenance history and prescribed treatment schedules
- Relative location of street segments to create multiple, continuous segments, consistency within neighborhoods, and project efficiency
- Number of public traffic attraction facilities such as schools, hospitals, libraries, community centers, etc.
- Community and City Council office feedback regarding roadway conditions and priority street segments
- Multi-year geographic spread across the city and street network

In 2021, DOT added an additional criterion: equity. DOT staff cross-referenced the selected zones with census tracts designated by the Metropolitan Transportation Commission as "Equity Priority Communities" (EPC), formerly known as "Communities of Concern" to better track equity in service delivery. Results confirmed that 287 out of 356 miles (roughly 80%) of local and neighborhood streets designated in EPC areas will be maintained by the end of the current three-year plan (2024). DOT anticipates completing pavement maintenance for nearly 65% of the Local and Neighborhood Street Network in this same timeframe.

Since 2019, DOT has maintained a total of 158 EPC miles and will be maintaining an additional 66 EPC miles in 2022, which is roughly 35% of the 190 miles of Local and Neighborhood Streets selected for maintenance in 2022. This project will maintain approximately 26 miles of streets in EPC neighborhoods, which accounts for approximately 14% of the scope of work.

The attachment to this memorandum contains the list of streets to be sealed. The list may change if unforeseen circumstances arise or new information regarding other projects becomes available.

ANALYSIS

Bids were opened on April 7, 2022 with the following results:

The low bid submitted by VSS International, Inc. is \$3,970,120 and is 4.9% below the Engineer's Estimate. The Engineer's Estimate for this project is \$4,172,340. The estimate is based on bids received from similar past projects and most current estimated construction prices. The bid is considered acceptable for the work involved in the project and no protests were received. Staff recommends that the construction contract be awarded to VSS International, Inc.

San José Municipal Code Section 27.04.050 provides that the contingency for all public works contracts (except those involving the renovation of a building or buildings) cannot exceed 10% of the total contract amount. Staff recommends an approximate 10% contingency, which should be sufficient to account for unforeseen conditions that might arise in the micro-surfacing project.

Construction is scheduled to begin in July 2022 and will be completed by late October 2022.

Project Labor Agreement Applicability

A project labor agreement is not applicable to this project as more than 50% of the scope of the work within the project is providing street maintenance for existing infrastructure.

Local and Small Business Outreach

This project does not have a preference for local and/or small businesses.

CONCLUSION

Based on the evaluation of bids, the low bid is considered acceptable, and staff recommends awarding the construction contract for the 2022 Local Streets Microsurfacing Project to VSS International, Inc.

EVALUATION AND FOLLOW-UP

DOT provides an ongoing evaluation of the City's pavement conditions and provides periodic reports on this topic to the Transportation and Environment Committee and the City Council. In addition to the project discussed in this memorandum, seven additional large pavement maintenance projects for Local and Neighborhood Streets are tentatively scheduled for City Council action this spring.

CLIMATE SMART SAN JOSE

The recommendation in this memorandum has no effect on Climate Smart San José energy, water, or mobility goals.

PUBLIC OUTREACH

To solicit contractors, this project was listed on an online bid solicitation website, Biddingo, where bid packages were made available to download for contractor organizations and builders' exchange. When the project commences the contractor will provide advance notification regarding working hours, duration of project, and any appropriate schedule and lane closures to affected businesses and residents, as stated in the specifications. To inform traveling motorists of upcoming construction activities and potential traffic delays, changeable message signs may be used on selected streets stating the scheduled date and time for work to occur on the street. This memorandum will be posted on the City's Council Agenda website for the May 24, 2022 City Council meeting.

COORDINATION

This project has been coordinated with the Department of Public Works, and this memorandum has been coordinated with the Department of Planning, Building and Code Enforcement, the City Attorney's Office, and the City Manager's Budget Office.

COMMISSION RECOMMENDATION/INPUT

No commission recommendation or input is associated with this action.

FISCAL/POLICY ALIGNMENT
