- Significant staff vacancy rate compounded by a constrained labor market
- Constrained partner capacity/workforce

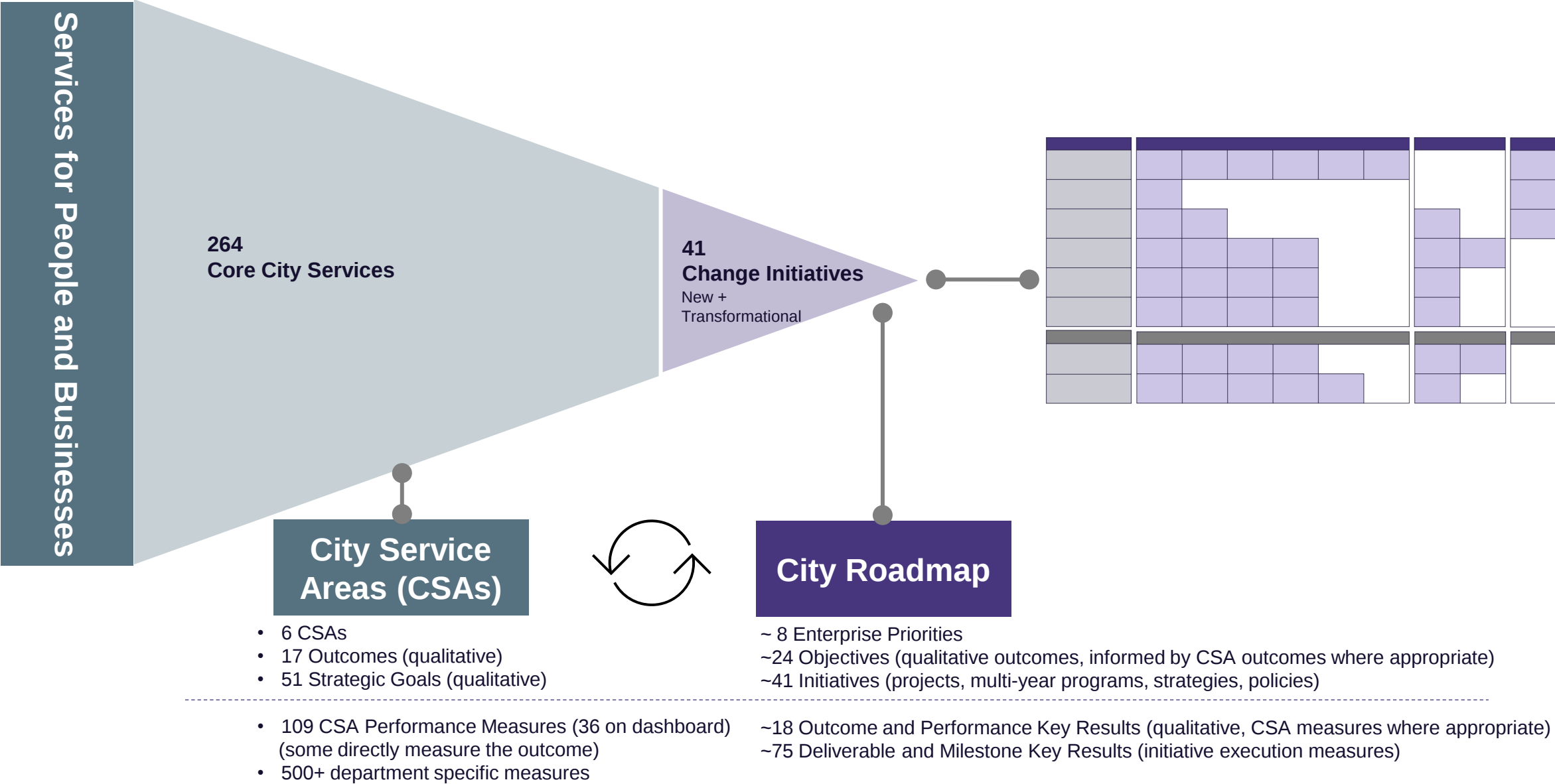

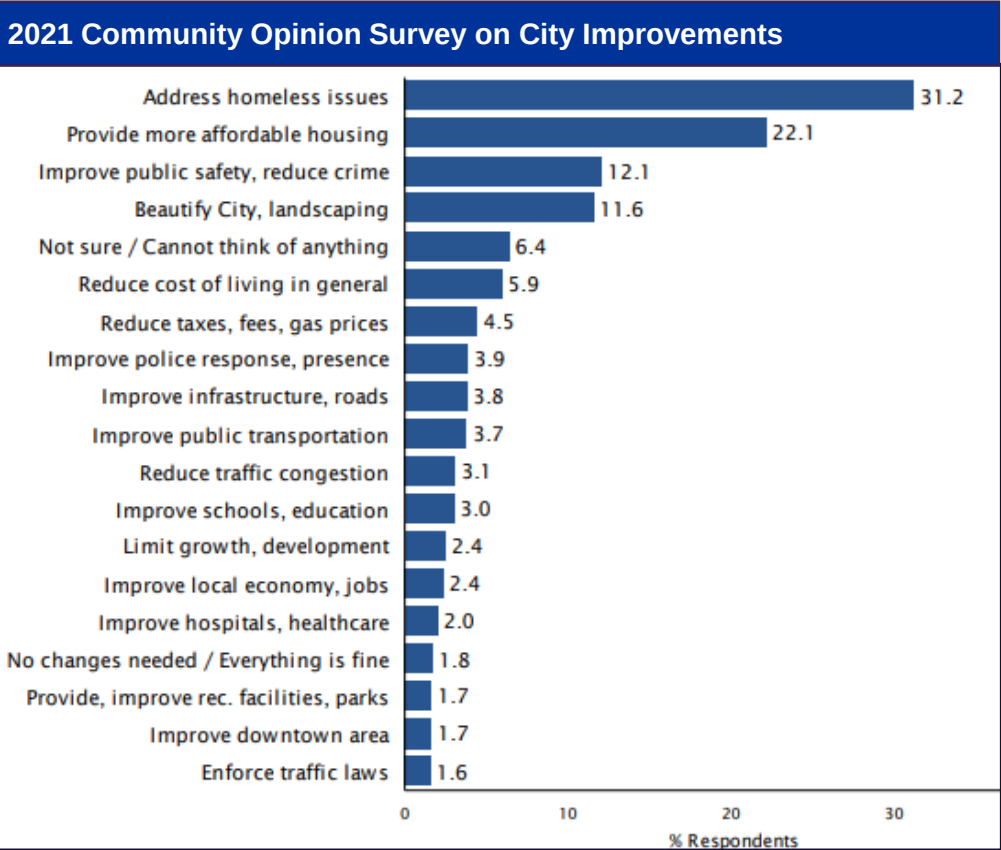

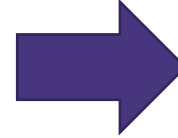
