- 4. Approve the Vista Montana Neighborhood Celebration to be held June 11, 2022 as a City Council Sponsored Special Event and approve the expenditure of funds.
- 5. Approve and accept donations from various individuals, businesses or community groups to support the events.
- 5. Place the item on the May 24, 2022 City Council Agenda for action.

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Penitencia Neighborhood Association Dumpster Day was held on May 14, 2022 at the southeast corner of Mary Caroline Drive and Ridgegate Drive as a City Council Sponsored Special Event and is sponsored by Councilmember David Cohen.

The Baypointe Interim Park Activation and Neighborhood Celebration was on May 18, 2022 at Baypointe Interim Park located at Baypointe Parkway and Zanker Road from 6 p.m. to 8 p.m. and is sponsored by Councilmember Cohen. The District 4 sponsorship of this event is intended to provide an opportunity for San Jose residents to socialize and enjoy food from a food truck together.

The Alviso Dumpster Day will be held on June 4, 2022 at Liberty Street as a City Council Sponsored Special Event and is sponsored by Councilmember David Cohen. Both special events will provide residents with an opportunity to bring a wide array of items to dispose of safely and conveniently.

The Vista Montana Neighborhood Celebration will be on June 11, 2022 at Vista Montana Neighborhood Park, located at 81 Vista Montana from 10:30 a.m. to 1 p.m. and is sponsored by Councilmember Cohen. The District 4 sponsorship of this event is intended to provide an opportunity for San Jose residents to socialize, meet one another, learn about city services and meet their local police officers. The events are free and open to the public and will follow all appropriate local public health rules.

#### **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember David Cohen will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 4, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.

The Office of the City Clerk will post the item on the City's Website for the May 18, 2022 Rules Committee Agenda and the May 24, 2022 City Council Agenda.
