A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING THE ANNUAL BUDGET REPORT FOR MAINTENANCE DISTRICT 20 (RENAISSANCE - NORTH FIRST LANDSCAPING) FOR FISCAL YEAR 2022-2023 AND LEVYING ASSESSMENTS

1. The Annual Assessment in the Annual Budget Report does not exceed the

average annual change in the San Francisco-Oakland-Hayward, CA Consumer

Price Index.

2. The Annual Budget Report and each of the assessments therein as duly revised

and corrected, are hereby approved, confirmed and adopted.

3. The Annual Budget Report quantifies any general and/or special benefit

contribution required from the City. City staff is directed to pay any required City

contributions as set forth in the Annual Budget Report.

4. The Annual Budget Report together with the certification of the City Clerk as to

the place and date of approval by the City Council, shall forthwith be delivered to

the Director of Public Works of the City of San José who shall thereafter deliver

the assessments to the officer of the County of Santa Clara designated by law to

extend City taxes upon the tax roll, and the proper County officer shall cause to

be posted to the tax rolls the assessments to be collected for the fiscal year as

set forth in the Annual Budget Report as confirmed.
