SUBJECT: NAMING OF A NEW PUBLIC PARK AT HAVANA DRIVE AND MIDFIELD AVENUE

RECOMMENDATION

Adopt an official name for a new public park based on the following alternatives:

- (a) "Mariposa Park" as recommended by staff and the Parks and Recreation Commission and as a result of a public outreach process; or
- (b) Select an alternative park name from the list of qualifying names generated through the public outreach process.

OUTCOME

Approval of the recommendation will provide an official name for a new public park. The name will be recognized in the City of San José's (City) park inventory and posted on a sign at the site.

BACKGROUND

The proposed park site is located on an approximately 0.16-acre vacant parcel, owned by the state of California, at the corner of Havana Drive and Midfield Avenue in the Tropicana-Lanai neighborhood, as shown in the Park Location Map, Attachment A. The park is in the Alum Rock Planning Area in Council District 7. The park is triangular in form and generally bounded by U.S. Highway 101 (U.S. 101) to the west; single-family residential homes to the north and east; and multi-family apartments to the southeast. The park is on the east side of the U.S. 101 sound wall, which reduces vehicular noise for the park site.

Members of the community, in partnership with Latinos United for a New America (LUNA), advocated and secured a portion of the resources to develop the vacant parcel into a park. City staff supported the community in park development.

The future park site development was guided by LUNA and supported by City staff and design professionals. Attachment B is the concept plan for this space. The park is anticipated to open to the public in 2023.

The community worked with the City's Office of Cultural Affairs to commission an artist to paint a butterfly mural on the U.S. 101 sound wall that borders the park. The mural, titled "El Sueño de la Mariposa" (The Dream of the Butterfly), was completed in September 2021 by muralist Morgan Bricca. Photographs of the butterfly mural are provided in Attachment C.

Through online and hard-copy surveys, community members expressed a preference to name the park "Mariposa Park" to reflect the butterfly mural on the U.S. 101 sound wall. Mariposa is the Spanish word for butterfly.

On April 6, 2022, the Parks and Recreation Commission voted (7-0-2-1 – Commissioners Choy and Vega absent; Commissioner Snider abstaining) to recommend adoption of the name "Mariposa Park" consistent with City Council Policy 7-5, Naming of City-Owned Land and Facilities, and the public outreach process.

ANALYSIS

City Council Policy Number 7-5, Naming of City-Owned Land and Facilities, (Policy 7-5) establishes guidelines and procedures regarding naming of City-owned land and facilities that are not public streets. Per Policy 7-5, the official names must be reflective of one of the following criteria:

- Geographic location;
- Prominent geographic feature or local reference point;
- Adjoining subdivision/community;
- Historical event;
- An individual who has made significant contributions to San José, the state, the nation, or the world and who has been deceased for at least five years;
- An individual via a donation or sponsorship agreement; or
- A group via a donation or sponsorship agreement.

Additionally, Policy 7-5 encourages names that reflect the City's ethnic and cultural diversity. Where possible, staff will recommend names that reflect the intention of Policy 7-5 as well as names that align with the City's Racial Equity commitment¹.

Staff recommends the City Council adopt "Mariposa Park" as the official park name. Staff finds that naming the park "Mariposa Park" aligns with Policy 7-5, as it reflects the butterfly mural (a prominent geographic feature and local reference point) on the U.S. 101 sound wall that abuts the park. The mural depicts images of a young child with mariposas (butterflies) in their habitat. According to the mural's artist, Morgan Bricca, "most of the residents of the community are first- or second-generation immigrants from Mexico and Central America, and the monarch migration theme in the mural symbolically parallels their own journeys. The girl represents the hopes and dreams every generation holds for their children."² The mural also features two prominent butterflies that function as "wing" backdrops for adults and children to take self-portrait photographs.

CONCLUSION

The recommended park name, "Mariposa Park" aligns with Policy 7-5 and reflects the highest preference ranking by the community. The recommended park name is also supported by the Parks and Recreation Commission. The selected name will appear on a sign at the park.

EVALUATION AND FOLLOW-UP

Once a name is adopted, staff will coordinate with the City Clerk's Office to ensure the name is recorded and the Public Works Department to include park signage during construction.

CLIMATE SMART SAN JOSÉ

The recommendation in this memorandum has no effect on Climate Smart San José energy, water, or mobility goals.

POLICY ALTERNATIVES

Alternative #1: Select an alternative park name from the list of eligible names generated through the public outreach process.

Pros: The City Council could adopt a name from the list of qualifying names received during the Department's public surveys. "Havana Midfield Park" and "Butterfly Park" were the second and third most preferred names in the Department's public surveys. "Havana Midfield Park" would reflect the name of the two cross streets that front the park: Havana Drive and Midfield Avenue. "Butterfly Park" would reflect the butterfly mural on the U.S. 101 sound wall that borders the park.

Cons: The City Council would be selecting a name other than the one recommended by the Parks and Recreation Commission and Department staff and that was supported by the community during the public outreach process.

Reason for not recommending: "Mariposa Park" was the highest ranked name by the community.

PUBLIC OUTREACH

Staff completed two rounds of online and paper public surveys. The first survey solicited name suggestions and the second survey allowed the public an opportunity to rank their preference for a qualifying name. The online surveys, which were completed via SurveyMonkey, were distributed through the Parks, Recreation and Neighborhood Services Department's electronic communication and social media networks to Council District 5, 7, and 8 staff, San José Park Advocates, San José Park Foundation, six business and neighborhood associations, and nine schools located within a mile of the park. Council District 7 staff in coordination with local neighborhood partners distributed paper versions of both online surveys to neighborhood residents. The survey period was between December 13, 2021 to February 4, 2022. The first survey was translated in English, Spanish, and Vietnamese. Staff did not receive any responses to the first Vietnamese survey nor requests for Vietnamese translation; therefore, the second survey was provided in English and Spanish.

Staff received 57 name suggestions in the first survey, with 15 qualifying names that aligned with Policy 7-5. In the second survey, staff utilized a ranked choice voting format where participants selected their top three name choices and ranked them in order of preference. Staff received 343 responses, which resulted in the following highest-ranking name preferences: 1) Mariposa Park, 2) Havana Midfield Park, and 3) Butterfly Park.

To calculate the highest-ranking name preference, the respondent's top three name choices are assigned a weight of three, two, and one (the larger weight equals a higher preference). For example, the first preferred name choice is multiplied by three, the second preferred name choice

is multiplied by two, and the third preferred name choice is multiplied by one. For every name option, the votes for each of the three preferences are multiplied by the assigned weight and added together. The result is then divided by the total number of survey responses received (343) to calculate the weighted score³. The name selection with the largest weighted score informed staff's recommendation. The results are shown in Table 1.

COMMISSION RECOMMENDATION/INPUT

This item was presented at the Parks and Recreation Commission on April 6, 2022⁴. Public comments requested the Commission accept staff's recommendation of "Mariposa Park." The Commission acknowledged the community's work on the development of the park and support for the name "Mariposa Park." Commissioner Ames motioned to recommend the name "Mariposa Park" to the City Council, which was seconded by Commissioner Barocio. The motion carried (7-0-2-1). Absent: Choy and Vega. Abstain: Snider.

FISCAL/POLICY ALIGNMENT

The proposed action aligns with City Council Policy Number 7-5, Naming of City-Owned Land and Facilities, and the City's 2009 Greenprint, Activate SJ, and the Envision San José 2040 General Plan.

Additionally, this park site addresses the need for a park within a ten-minute walk of the surrounding area and provides a new park in a neighborhood and Council District that is deficient in parkland.
