WHEREAS, as specified in Resolution No. 80524, a public hearing concerning the levy of assessments for Fiscal Year 2022-2023 was held before the Council on June 21, 2022, at the meeting beginning at the hour of 11:00 a.m. (to be heard no sooner than 1:30 p.m.) in the Council Chambers of the City of San José, 200 East Santa Clara Street, San José, California, or by teleconference that is open to the public and enables public comment; and
