SUBJECT: CITY ROADMAP - PAVEMENT, FIRE, EOC, TRANSIT CAPITAL IMPROVEMENTS: 2022 LOCAL STREETS RESURFACING #6 PROJECT

RECOMMENDATION

- Approve award of a construction contract for the 10164 2022 Local Streets Resurfacing (a) #6 Project, to the lowest bidder, A. Teichert & Son, Inc., in the amount of \$9,056,338.
- (b) Approve an approximate 10 percent contingency in the amount of \$905,000.

OUTCOME

Approval of this contract will provide preventive maintenance on approximately 19 miles of streets on the Local and Neighborhood Street Network in the 2022 construction season. Approval of an approximate 10 percent contingency will provide funding for any unanticipated work necessary for the proper construction and completion of the project.

BACKGROUND

The Department of Transportation (DOT) will maintain approximately 190 miles of streets on the Local and Neighborhood Street Network in the 2022 construction season. Of the 190 miles, DOT is planning to resurface approximately 135 miles of streets in poor to failed condition, supported by the third annual allocation of \$37.5 million in Measure T funds.

Pavement maintenance is typically performed in two separate phases: preparation and a final surface application. The preparation phase consists of the installation and upgrade of Americans with Disabilities Act curb ramps along the 135 miles of Local and Neighborhood streets planned for resurfacing. The preparation phase was included in two concrete projects previously

presented to City Council in April of 2022. The contract proposed in this memorandum will resurface approximately 19 miles of streets. Resurfacing of streets generally includes the repair or replacement of damaged pavement, application of a new layer of asphalt, installation of new roadway striping and markings.

To decrease the overall timeframe for completing the pavement work, DOT is dividing the resurfacing projects into six separate projects; of which this project will be the sixth. A description of 2022 pavement maintenance projects was provided in an information memorandum to City Council in February 2022.

The City of San José's (City) Local and Neighborhood Street Network is organized into 135 geographically contiguous Pavement Maintenance Zones (PMZs). The PMZs were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic equity of pavement maintenance across the City. Information provided by the City's pavement management database is used to identify candidate PMZs for preventive maintenance and sealing. The final list of PMZs to receive treatments was established using the following criteria:

- Funding availability and funding use restrictions
- Streets on the Local and Neighborhood Street Network
- Streets not affected by current or future street related projects
- Maintenance history and prescribed treatment schedules
- Relative location of street segments to create multiple, continuous segments, consistency within neighborhoods, and project efficiency
- Number of public traffic attraction facilities such as schools, hospitals, libraries, community centers, etc.
- Community and City Council office feedback regarding roadway conditions and priority street segments
- Multi-year geographic spread across the City and street network

In 2021, DOT added an additional criterion: equity. DOT staff cross-referenced the selected zones with census tracts designated by the Metropolitan Transportation Commission as Equity Priority Communities (EPC), formerly known as Communities of Concern, to better track equity in service delivery. Results confirmed that 287 out of 356 miles (roughly 80 percent) of local and neighborhood streets designated in EPC areas will be maintained by the end of the current three-year plan (2024). DOT anticipates completing pavement maintenance for nearly 65 percent of the Local and Neighborhood Street Network in this same timeframe.

Since 2019, DOT has maintained a total of 158 EPC miles and will be maintaining an additional 66 EPC miles in 2022, which is roughly 35 percent of the 190 miles of Local and Neighborhood streets selected for maintenance in 2022. This project in particular will maintain approximately

15 miles of streets in EPC neighborhoods, which accounts for approximately 79 percent of the scope of work.

The attachment to this memorandum contains the list of streets to be resurfaced. The list may change if unforeseen circumstances arise or new information regarding other street-related projects becomes available.

ANALYSIS

Bids were opened on May 12, 2022 with the following results:

The low bid submitted by A. Teichert & Son, Inc. is \$9,056,338 and is 1.32 percent below the Engineer's Estimate. The Engineer's Estimate for this project is \$9,206,283. The estimate is based on bids received from similar past projects and most current estimated construction prices. The bid is considered acceptable for the work involved in the project. Staff recommends that the construction contract be awarded to A. Teichert & Son, Inc., who has completed previous paving projects throughout San José; one of which includes DOT's 2021 Local Streets Remove & Replace project. No protests were filed for this project.

San José Municipal Code Section 27.04.050 provides that the contingency for all public works contracts (except those involving the renovation of a building or buildings) cannot exceed 10 percent of the total contract amount. Staff recommends an approximate 10 percent contingency, which should be sufficient to account for unforeseen conditions that might arise in the project.

Construction is scheduled to begin in July 2022 and will be completed by October 2022.

Project Labor Agreement Applicability

A project labor agreement is not applicable to this project as more than 50 percent of the scope of the work within the project is providing street maintenance for existing infrastructure.

Local and Small Business Outreach

Procurement staff used Biddingo to outreach to local and small business enterprises. Chapter 4.12 of the San José Municipal Code defines a "local business enterprise" as one with a legitimate business presence in Santa Clara County and "small business enterprise" as a local business enterprise with 35 or fewer employees. Procurement staff sent bid invitations to 7,820 vendors, and documents were downloaded by 18 venders, approximately three of which were located within Santa Clara County and therefore local. The recommended contractor is not a local or a small business enterprise. In addition, none of the listed subcontractors are a local or a small business enterprise.

CONCLUSION

Based on the evaluation of bids, the low bid is considered acceptable, and staff recommends awarding the construction contract for the 2022 Local Streets Resurfacing #6 Project to A Teichert & Son, Inc.

EVALUATION AND FOLLOW-UP

DOT provides an ongoing evaluation of the City's pavement conditions and provides periodic reports on this topic to the Transportation and Environment Committee and the City Council.

CLIMATE SMART SAN JOSE

The recommendation in this memorandum has no effect on Climate Smart San José energy, water, or mobility goals.

PUBLIC OUTREACH

To solicit contractors, this project was listed on an online bid solicitation website, Biddingo, where bid packages were made available to download for contractor organizations and builders' exchange. When the project commences the contractor will provide advance notification regarding working hours, duration of project, and any appropriate schedule and lane closures to affected businesses and residents, as stated in the specifications. To inform traveling motorists of upcoming construction activities and potential traffic delays, changeable message signs may be
