Dear Mayor Liccardo, Councilmembers, and City Clerk,

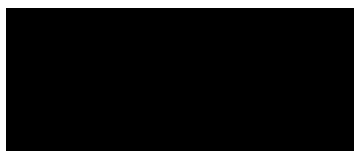
The Guadalupe River Park Conservancy submits this letter for a one-time consideration of \$54,000 allocation in the upcoming City Budget FY 22-23. Funds would support the hiring of a part-time horticulturalist to provide specialized expertise in botanical care in the Guadalupe Gardens, public programming support, promotion and program measurement, and supplies to address both the needs of enhanced horticulture and repair stewardship elements in the Guadalupe Gardens.

Funds would align with a number of priorities in the Mayor's March budget message:

- **Battling blight and supporting parks:** specialized horticulture care would enhance existing park assets at the Guadalupe Gardens and encourage more park usage. Repairs to fencing, toolshed, and other Gardens structures would enhance the efficacy and experience of our volunteers.
- **Health of the urban forest:** support would increase the survivability of our Historic Orchard and Heritage Rose Garden, which has undergone significant restoration efforts last year. The increase in biodiversity, and the challenges of an extended drought, warrant expertise to ensure the Orchard and Rose Garden will provide health and environmental benefits for the next generation of San Joseans.
- **Community programming:** this allocation request would promote park use, volunteerism, neighborhood health, and civic pride, in line with stated Budget Message goals around park activation and cultural programming. Strengthening connections between residents and our agricultural history and natural landscape would uplift the unique civic and natural resources formative to our city.

To maximize the use of funds from this one-time allocation, the scope would also include horticulture-related public programming to build capacity and education around the planting needs in the Gardens, empower neighborhoods to care for their River Park, public promotion, and measurements that track stewardship and program milestones. We thank the Mayor and City Council for your ongoing leadership and we look forward to your consideration of our request, which we believe aligns with many existing City and community priorities.

I'm writing to you as an avid biker to thank you for prioritizing the importance of street safety. There has been an impressive commitment to the issue of bicycle safety for many years.

I appreciate that San Jose is one of the few cities in the area to have formally adopted the Vision Zero initiative, with the ultimate goal of eliminating severe injuries and traffic deaths, as well as improving the safety of roadways. I have family members that have been personally impacted by close calls on the roads.

While I do applaud that bike projects are in the pipeline as part of the Pavement Maintenance Program in San Jose, these are long-term projects, and we also need shorter-term solutions. I ask the council to please consider increasing funding for quick-build projects including funding staff to manage these projects.

Finally, I would like the council to consider funding bike safety and infrastructure from the general fund budget as a way of demonstrating commitment to the cycling community.

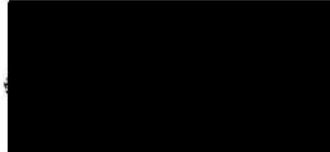

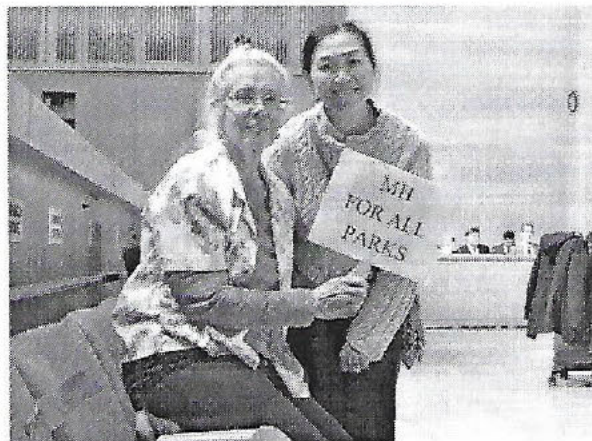
SUPPORT – Budget requests from Councilpersons Perez, Foley and Jimenez

On March 10, 2020, the San Jose City Council voted unanimously to approve the designation for all Mobilehome Parks in San Jose as MH – Mobilehome. Previously, this action had been delayed twice since 2015.

Tonight, on behalf of mobilehome residents, you can put that previous commitment into action by approving the one time funding request for the staffing to carry out that work.

On March 10, 2020, the Mobile Park residents who packed Council Chambers, spilled into the overflow room, stood in line to testify at the microphone, sent emails and letters and signed petitions, went home with a sense of relief and gratitude.

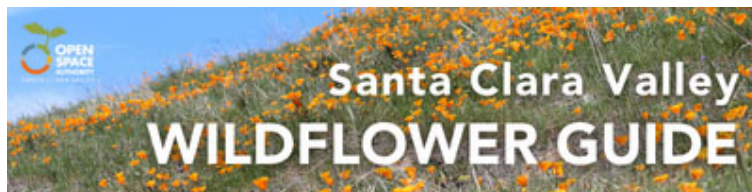

Dear Mayor, City Councilmembers,

On behalf of the Santa Clara Valley Open Space Authority (Open Space Authority), I am writing to support the recommendations in the Mayor's June Budget Message for Fiscal Year 2022-2023 related to Monterey Road Wildlife Corridor Safety Improvements (Page 16), Tree Planting (Page 21), and Parks and Trails (pages 25-27).

The Open Space Authority is a public, independent special district created by the California State Legislature in 1993 to conserve the natural environment, support agriculture, and connect people to nature by protecting open spaces, natural areas, and working farms and ranches for future generations.

As stated in the memo, the greatest barrier to wildlife movement across Coyote Valley is Monterey Rd. The tall median barrier poses an impenetrable impediment to wildlife trying to cross to safety, and thereby creates a significant hazard for them as well as for motorists. Funding provided by the City to POST, and matched by POST and supported by the Open Space Authority, would make possible a wildlife crossing infrastructure feasibility study that provides a pathway to substantial improvements for wildlife and motorists alike. This modest investment by the City would reinforce and enhance the investment the City has already made in natural infrastructure in Coyote Valley, provided by funds from Measure T, which was overwhelmingly approved by voters in 2018.

The Open Space Authority also supports the recommendations for Tree Planting related to the City's recently approved Community Forest Management Plan (CFMP), and looks forward to continuing the partnership with City staff on implementing the CFMP. Increasing tree canopy, especially for those neighborhoods in the City that have the most depleted canopies, is extremely important, to help combat urban heat island effect, and for quality of life.

We are also in strong support of the many park and trail actions being recommended in the memo on pages 25 through 27. The Open Space Authority continues to experience very high visitation rates at its preserves, as well as high demand for outdoor nature-based programming. Improvements and expansions to City parks, trails, and community gardens, including support of the excellent work Veggielution is doing in partnership with the City at Emma Prusch Park, would be extremely important to provide greater outdoor access for San Jose residents close to home.

Further, we encourage the City of San Jose and its partners to apply to the Authority's Urban Grant Program for additional support of public access to natural areas.

Thank you for the opportunity to provide these comments. The Authority appreciates the attention given to funding of these natural resource and public outdoor access issues in the Mayor's memo, and strongly encourage the City Council to approve these recommendations.

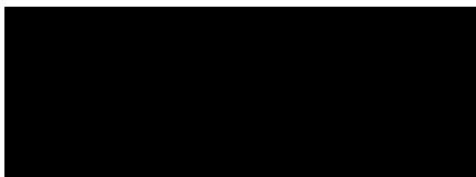

I'm reading this excerpt from the [MBA on Vision Zero](#), and it's incredibly disheartening to read that there aren't any resources to dedicate a full-time position to this work, because of limited receipts in the Building and Structure Construction Tax and the Construction Excise Tax.

While grant-supported project funding will likely increase in the coming years, City revenues within the Traffic Capital Program – primarily receipts from the Building and Structure Construction Tax and the Construction Excise Tax – are more limited. If the pace of development exceeds forecasted expectations, and depending on the level of vacancies within DOT, as well as other important City priorities for the transportation network, the

Administration will recommend a dedicated full-time position to evaluate implemented Vision Zero safety work on a consistent basis and in a timely manner. The analysis would be based on a review of pre/post traffic data, field observations and user surveys. DOT has explored the use of consultants for this service and based on informal bid results, internal staff would be able to perform this work at a significantly lesser cost. As discussed later with regard to Item 6, DOT has reprioritized existing staff within the neighborhood traffic management team to help focus review of fatality and citywide collision data.

In April of 2021, I wrote you all to question why we were diverting \$500,000 from dedicated repaving funding (based on Council policy) to an airport connector. I mentioned that speeding up repaving means implementing safety elements sooner, since staff incorporate bike/ped improvements when repaving. I cited the years of record-setting traffic deaths, and yet you all continued to fund the Mayor's airport connector priority. Now, the City is on a new record pace and staff is saying there isn't enough money.

The MBA should mention that the City made the decision to divert available resources to a project like the airport connector that has no effect on traffic safety. What a shame.

Good Morning Councilmember Peralez,

I appreciated your question yesterday morning during the Transportation Budget Study Session about potentially speeding up the implementation of Vision Zero/Betterbikeways safety-type projects. I want to call out Page 17 in the CIP (graphic below). It essentially mentions that excess Construction Excise taxes that were previously prioritized for Pavement Maintenance & Traffic Safety projects, are now recommended by the administration to be diverted to other uses. As you know, even pavement maintenance \$\$ can speed up the installation of traffic safety projects, since often times DOT will include planned safety improvements with resurfacing efforts since they're tearing up the street anyway.

Budget Director Jim Shannon sent a table which highlights that of this excess Construction Excise taxes, about \$4 million that would've been prioritized for pavement maintenance & traffic is now being diverted. This is definitely money that can and should still go to traffic safety improvements (Vision Zero projects) to speed up implementation. Also, if staffing is needed to deliver the added capital \$, this funding source is used for CIP staffing as well, as found in the CIP.

I take issue with multi-modal planning & an airport connector taking much-needed money from traffic safety projects, since both of those aren't life or death efforts.

I saw this section of the MBA on Vision Zero and something jumped out at me. It mentions evaluating projects to refine quick-build elements to improve outcomes. It also mentions speed, volume, and collision data being collected to assess a reduction in travel speeds and crash frequency or severity.

Staff is getting rid of the protected bike lane on San Antonio based on no data other than complaints from neighbors about sightlines, despite not seeing any collision data to back up their complaints of it being more dangerous for drivers.

Staff also cited that debris in these protected bike lanes meant riders often didn't use them anyway, reducing the benefit of the lanes. The budget includes funding for more street sweeping and another bike-lane street sweeper (smaller in

size). There's no reason to release an evaluation report in May that says there's too much debris in the protected bike lane when the Proposed Budget includes funding for more street sweeping resources, specifically for protected bike lanes.

Are we evaluating projects to see if they effectively address Vision Zero, or are we evaluating them to see how popular they are with drivers?

#2) Direct City Staff to evaluate the effectiveness of all traffic safety projects implemented since adoption of the 2019 Vision Zero Action Plan. Furthermore, increase staffing resources, through the upcoming budget process if needed, to expedite data analysis and project evaluation as well as conducting synchro analysis related to recommendation #5.

Evaluate the Effectiveness of Projects: Post project evaluation work for McLaughlin Avenue, Senter Road, San Antonio Road, White Road, and 10th and 11th streets is underway and is expected to be completed this summer. Speed, volume, and collision data are being collected and reviewed for effectiveness in reducing travel speeds and crash frequency or severity. For projects that were completed within the past year (such as Senter Road and San Antonio Avenue), qualitative on-the-ground roadway user surveys are also being conducted. These surveys will also be used to refine quick-build elements where needed to improve outcomes. Much of this evaluation work is being performed by existing project staff.

As a member of the REAL coalition, Catholic Charities supports the REAL budget recommendations.

We appreciate the City's efforts to move some of these priorities forward. At the same time, more needs to be done to promote racial equity and inclusion.

Based on our long and close working relationship with the City to address many of the challenges facing our residents, Catholic Charities encourage the City Council to put more resources into several priority areas:

1. **Food Distribution:** The pandemic is not over. Economic hardship and income inequality are rising due to increased inflation. Our staff and volunteers are seeing increased numbers of families seeking food at our parish drive-through distribution sites throughout San Jose. While we are grateful for the opportunity to seek additional funding for one more quarter to assist in distribution, the need continues to rise. We appreciate the City reaching out to the County for joint talks, but to date the County has not committed to fund food distribution other than through the shelter system and the normal senior nutrition system. Meanwhile tens of thousands of families in San Jose are still going hungry. The nonprofit sector can't solve this by ourselves. We need your help. The City has been a valuable and essential partner in the solution and until the County is willing and able to step up, our neighbors will still need the City's help.

Recommendation: Double the investment of ARPA funds in food distribution while continuing to coordinate, advocate and negotiate with the County to do its part to address hunger in our community.

2. **BEST Prevention and Intervention:** The most humane, efficient and cost-effective way to address criminal justice is to prevent the causes of youth violence and involvement in the system. The City has a proven model of an alternative to the increased cost of policing with the Mayor Gang Prevention Taskforce and the BEST programs. As a BEST partner Catholic Charities stands ready to partner with the City to develop new approaches that are trauma-informed.

Recommendation: Build on those successes by investing more resources in what is working in the BEST programs and scale them. Develop trauma-informed models and mental health supports that have been proven to work in

other communities.

3. Promotoras and Civic Engagement: Catholic Charities is encouraged by the proposed funding of a Promotora pilot in San Jose. One powerful way to engage local neighborhood members in creating a just and compassionate community is by training community members in peer support to help families navigate services and address their needs. Catholic Charities has found that families trust trained neighborhood members to connect them to the community resources they need. It not only improves family wellbeing, but also the health of the community.

Recommendation: Fully fund the Promotora Pilot.

We hope it goes without saying that not only were the City's nonprofit partners key responders to the pandemic, but also that the City will continue to rely on nonprofits to be efficient and effective service deliverers and trusted messengers between the City and the community.

We are grateful for the analysis in MBA#28 and the acknowledgement of nonprofits' cost needs, and it is important to point out that nonprofits (and we all) are facing unusually exorbitant increases in operations costs as well as significant challenges in hiring and retention in the current job market; all while, we struggle to return to a new normal in this liminal time of partial recovery and ongoing pandemic response.



Even in good times—because of funder practices that limit overhead and sometimes even require match requirements—nonprofit sustainability is often just an oasis on the horizon. Organizations that build healthy infrastructure—IT and data systems; financial systems; fund development processes; strategic plans; staff capacity building; and safe, efficient, and accessible physical spaces—are more likely to succeed than those that do not. The cost of not succeeding is high:

The effects of such limited overhead investment are felt far beyond the office: nonfunctioning computers cannot track program outcomes and show what is working and what is not; poorly trained staff cannot deliver quality services to beneficiaries. (*The Nonprofit Starvation Cycle*, A. Goggins & D. Howard, Stanford Social Innovation Review (2009).)

Nonprofit instability contributes to community instability. And the converse is true. The organizational health of the same nonprofits that were incredibly nimble during the pandemic and stepped up to respond to community needs will be needed if we are to “build back better.”

Over the last two years, the City of San José stepped up to fund nonprofits, funded technical assistance and training for nonprofits; purchased PPE and other essentials for nonprofits, recruited volunteers for nonprofits, and disseminated information to nonprofits. For example, dozens of organizations were provided with rescue funding by the City of San José through the Coronavirus Relief Funds (CRF) Nonprofit Grant Program, focused on services to communities in designated zip codes. The City’s Local Assistance Center set up a CBO liaison function that worked with SVCN to provide information to nonprofits about its services and plans and to serve as a conduit for input to the City’s response to COVID. Whereas some of this support was specific to the pandemic, we would like to see the City continue to support nonprofits much in the way that it regularly supports other small businesses.

We ask that the City continue to be a good partner to nonprofits by addressing the cost increases that we experience year over year—which are particularly pressing this year with a CPI of nearly 5% over the last year—by providing a cost of doing business increase in this year’s budget and future budgets as a best



practice. This should include General Fund contracts and pass-through contracts. By way of benchmarking, this year, Santa Clara County provided a minimum of 4% cost of doing business adjustment for its nonprofit partners.

Lastly, we hope the City Council will strongly consider the requests made by members of the Race Equity Action Leadership (REAL) coalition.

On behalf of Peninsula Open Space Trust (POST), I am writing in support of the spending recommendations in the Mayor's June Budget Message for Fiscal Year 2022-2023 related to Monterey Road Wildlife Corridor Safety Improvements (Page 16-17) and to thank the city for considering such an important investment.

POST is a non-profit established in 1977 that has preserved more than 80,000 acres of open space in the South Bay and across the San Francisco Peninsula. Collaboration with the communities we work in, fellow non-profits, and local governments is a vital part of how we do our work.

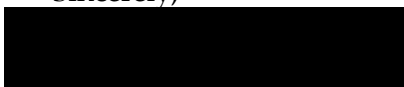
POST and Santa Clara Valley Open Space Authority (SCVOSA) are working together to create and enhance wildlife crossing infrastructure in Coyote Valley. **Monterey Road is the leading contributor of wildlife-vehicle collisions in Coyote Valley.** Surveys along major roadways in the area show that more than 63% of all roadkill was on Monterey Road – more than 5x the amount documented on any other road within the area. This represents not only an issue for local wildlife, but *also* a major motorist safety issue.

Later this year, POST in collaboration with SCVOSA will begin a **Monterey Road Wildlife Crossing Infrastructure Feasibility Study** (Feasibility Study) to evaluate constructing wildlife crossings along Monterey Road. This Feasibility Study will also identify near-term modifications to the Monterey Road median and glare screen to increase permeability for wildlife, reduce wildlife-vehicle collisions, and ensure motorist safety.

Wildlife crossing infrastructure projects may take years or even decades to complete, but in the meantime, improving the Monterey Road median barrier or replacing it with a wildlife-friendly median and implementing additional safety measures represent lower-cost, near-term options that can help improve motorist safety and reduce wildlife mortality. With the Mayor's \$100,000 recommendation for these Monterey Road Wildlife Corridor Safety Improvements, POST would be able to launch an important first step in our Feasibility Study. POST would also work with the City of San José and Caltrans to ensure that the median barrier modifications comply with the Caltrans Standards Plan and meet goals related to motorist safety and alleviating wildlife-vehicle collisions.

We thank you for your consideration and responsiveness to important and timely wildlife connectivity and motorist safety improvement opportunities.







We support the Mayor's budget recommendations in addition to the [Mayor's supplemental memo](#) recommending a budget be allocated for Al Fresco, specifically for the design of permanent closure of San Pedro Street and costs associated with the closure of Post Street. Moreover, we support Councilmembers Peralez, Carrasco, Davis, and Arenas [memo item 1.a.](#) to expand the Post Street pilot to a full year.

With Transient Occupancy Tax (TOT) program funds for art, culture, and hospitality dollars dwindled, we also support the memorandum from Councilmembers Peralez, Carrasco, Davis, and Arenas, specifically [item 2.](#), calling for the reallocation of our TOT into our art, culture, and hospitality industries as the General Fund has rebounded to a healthy and balanced budget with an [expected surplus of \\$30.1M](#) FY 22-23. The low travel and visitor turnout since covid has led to a lackluster tax-base for TOT and this has resulted in subpar fiscal aid for our arts and hospitality community which in turn has had a detrimental impact on our local economy. Thus we support the recommendation to reappropriate the General Fund TOT equally across the OCA Arts Grants Program, the Convention & Visitors Bureau, and the Convention and Cultural Facilities Fund in addition to providing a long-term budgetary strategy for a sustainable financial future.

We also have appreciated the extensive dialogue of how to allocate limited funds and the continued support for the center city - [specifically in these areas](#):

- **2. Public Safety - Police Walking Patrol:** The "implementation of a five-day/week model of Downtown walking patrol" starting in June of 2023 is severely needed as the current foot patrol shifts are voluntary overtime shifts for officers and therefore difficult to fill consistently. A stable and sustainable program dedicated to improving safety in downtown San Jose is a long term investment strategy for our city.
- **3. Eradicating Blight - Downtown Streets Team:** The gateways to our downtown have been an issue in which the freeway underpasses need substantial aid. Expansion of the program is needed and transitional employment is also a plus.
- **7. Community-Building, Place Making, and the Arts -**
 - Downtown Ice/holiday activations: Public space activation is important and continues to be where our community can come together, especially during the holiday season. We



believe this is a critical time as we look at enhancing the experience of residents, employees, and visitors.

- *Paseo de San Antonio Update*: Paseos play a crucial role in place-making opportunities and this supports ground floor activation and safety connecting SJSU to Downtown West.
- *Children's Discovery Museum*: Replacing equipment is vital to the maintenance of this facility and continuing the programming for our community.
- *3Below Theater Up on the Roof and SubZERO Festival*: We have supported these programs in the past and each of these events add to the authentic San Jose experience.

Green Foothills supports the allocations in Mayor Liccardo's June Budget Message for fiscal year 2022-23 related to Monterey Road Wildlife Corridor Safety Improvements, Tree Planting, and Parks and Trails. We request the Council to please approve these budget allocations.

Monterey Road Wildlife Corridor Safety Improvements

Monterey Road is currently a roadkill hot spot. According to the 2019 report ["Recommendations to reduce wildlife-vehicle collisions on the Monterey Road corridor in Coyote Valley"](#) by the Santa Clara County Wildlife Corridor Technical Working Group, more animals are struck and killed by vehicles on the stretch of Monterey Road that goes through Coyote Valley than on Highway 101. This situation is not only terrible for wildlife connectivity, it creates a serious safety hazard for drivers.

The recent action by this Council to protect Coyote Valley as open space, habitat and farmland was hugely important for wildlife habitat and connectivity through Coyote Valley. However, this work cannot be considered complete while Monterey Road remains a roadkill hot spot. The wildlife crossing infrastructure feasibility study that would be partially funded through this \$100,000 budget allocation is the first step towards remedying this untenable situation, which has persisted for far too long.

Tree Planting

We strongly support investment in increasing the urban tree canopy, especially in neighborhoods that are lacking in trees and urban green space. We urge the City to focus on native trees in this tree-planting effort, both to conserve water and to provide habitat and increase biodiversity. In addition, we urge the City to invest in protecting and maintaining the existing tree canopy as part of the goal of increasing the total number of trees, since every healthy tree that is cut down puts the City farther away from its goal.



Parks and Trails

We support the proposed allocations for park and trail improvements, especially the funding for Emma Prusch Farm Park and Veggielution. Community farms such as Veggielution not only provide ecosystem services, they serve as community hubs and as a source of locally-grown fresh produce for families in need.

I am writing to express overwhelming support and appreciation for Councilmember Arenas & Carrasco's Memo for the Mayor's June Budget.

From 2020 to 2021 YWCA saw a 576.25% increase in referrals for sexual assault survivors from San Jose Police Department. This increase in referrals was due to a number of factors. SJPD and YWCA have greatly improved our working relationship through having an embedded advocate, increasing our communication, and simplifying our referral process. These collaborative efforts have helped to see that survivors are informed of their rights, have access to an advocate at the time of reporting, and experience a more survivor-centered approach from the initial point of contact.

Survivors rely on the systems in place to be able to provide support in a timely and comprehensive manner. YWCA staff are dedicated, and relentless in their support of survivors. We make every effort to provide services as quickly and seamlessly as possible, there simply are not enough staff to provide in-depth services for the increased need for services we are seeing. What this looks like is that a survivor may have access to a support group, but not be connected to a case manager. Case managers are critical in empowering survivors, navigating systems, and providing on-going advocacy and accompaniment throughout the duration of a case (whether that be within the system officially or not).

Survivors deserve to have access to services immediately and in an ongoing manner for their unique healing journey. Having two additional advocates as well as more infrastructure for SJPD is a critical step in addressing the gaps we currently face. Investing in supporting survivors now is an investment in the well-being of our community.

Dear Mayor and City Councilmembers:

The Law Foundation of Silicon Valley writes to urge the City allocate sufficient funding to support the goal of changing the General Plan designation of all mobile home parks in San Jose, and not limit the funding to only changing the general plan designation to five parks. In March 2020, the City Council approved changing the general plan designation of all 58 remaining parks, after learning that the largest mobile home park in the City was at risk of closure. While that work was stymied because of the pandemic, it is critical that the City continue the important work of preserving mobile home parks through the changing the General Plan designation of all Parks, and prioritize this in the budget. When mobile home parks closed, not only do residents face displacement, but San Jose loses one of the only affordable homeownership opportunities available to low-income families.

As mobile home parks continue to be at risk of development, this City should **take all necessary steps to prioritize** that the over 35,000 mobile home residents, many low-income, seniors, and people of color remain in San Jose. We cannot predict which mobile home park may be next at risk of closure --- all should be protected. When that many residents are at risk of displacement, the answer should never be that we have done enough as a City, but instead that we will take the most protective steps we can with urgency. We urge Council to allocate the budget so that this can work can be prioritized take the most protective steps to protect all Parks now.
