
Council Members,



Kids in Common supports MBA #31 which outlines the expansion of City of San José preschool, afterschool and other recreational programming opportunities at school sites to increase access for low-income, vulnerable students.

Programs that create supportive pathways of success for young people are vitally important to our societal fabric. Over the past year, our San José school communities have grappled with the challenges of returning to in-person learning. At the high school level – in particular – campuses saw an increase in truancy, violence, and suicide due to trauma, instability, and lack of connection. All students in San José, but especially those from marginalized communities, are in need of an unprecedented level of support.

In fact, research indicates that this "opportunity gap" – access to out-of-school time supports and summer programming – may be responsible for up to two thirds of the academic gap we see between low-income children and middle- and high-income children.

We are also in support of BD #75 (Transforming School Cultures) which will set the foundation for a long-term system and culture shift at key school sites within the East Side Union High School District – helping bridge the expertise of teachers, administrators, and students to advance a districtwide Equity Agenda. The primary outcome of the Transforming School Cultures pilot is to support the school site in building and sustaining the school culture they envision by identifying and implementing strategies that maximize limited time and resources.

The Covid -19 pandemic has illustrated the need for us to redistribute resources, change policies and create alternative solutions to address social, racial, and economic injustice. We have seen a great need to address housing now via preservation, enhance childcare services, fully fund youth /senior programs, preserve historical places, and the urgency to support our youth to become the leaders of their schools.

SOMOS Mayfair and as part of the SSPC we would like to support the following items because we believe these solutions will create a more powerful, just and thriving East San Jose.

We strongly support the following items:

1. <u>MBA #31</u> authored by CM's Arenas and Carrasco- the expansion of City of San José preschool, afterschool and other recreational programming opportunities at school sites to increase access for lowincome, vulnerable students.

a. Childcare is a fundamental service we must provide. Youth are in dire need of recreational and youth development opportunities that are fully funded for them to thrive.

2. We hope that in the future we can work together to increase support, services and transformative solutions for East San Jose, Mayfair and the Alum Rock Schools region.




