

When I retired from the San Jose Mercury News in 2013, one of the primary reasons was to work with non-profit arts and community groups in San Jose. (As arts and entertainment editor of the paper, it would have been a conflict of interest to work with them while still at the paper.) Since my retirement, I have worked with a number of arts groups and joining the Arts Commission would be a next step in what I see as my being an advocate for a robust arts community in the city. Clearly, with the demise of such key arts organizations as the San Jose Rep and the Ballet San Jose, we now face a true challenge in both maintaining the rich, vibrant culture our city has and building on that foundation as we move forward. I would use my experience and energy to work towards that goal. Specifically, I would hope to solve the venue issues faced by many smaller companies, help to increase the collaboration between San Jose's diverse arts groups and raise public awareness particularly among our younger citizens of the arts and entertainment San Jose has to offer.

I have been a member of the San Jose Arts Commission since February 2017 and feel I have contributed to the work of the commission during that time. Over the past four years, I have served on the boards of the City Lights Theater Company, the Happy Hollow Park & Zoo Foundation and the San Jose Downtown Association Foundation. All have very different issues facing them and I feel I have been able to contribute to the board's work on all three. At City Lights, I was voted president of the board in 2015-17. At Happy Hollow, I served as chair of the board's Government Relations Committee as well as working extensively on its signature fundraising event, Hoot and Howl.

I am currently the a board member and fund development chair for Local Color (close to three years) and was previously an Executive Board Member for New Leaders Council Silicon Valley (two years). I also have relevant experiences. This includes working directly with the San Jose Downtown Foundation Board of Trustees as the Downtown Doors Director, learning nonprofit board mechanics and trainings as a Fellow for Latino Board Leadership Academy, and being a current cohort member for Latino Leadership Alliance whose mission is to empower Latino civic leadership by identifying, developing, and supporting emerging leaders (across sectors). These experiences, combined with my upbringing, will set me up to serve as a strong art commissioner that can collaborate with fellow commissioners, and a wide variety of constituents to support agreed upon initiatives.

As Partnerships Manager for San Jose Downtown Association (SJDA), I leveraged my ability to drive valuable relationships and applied this function across a variety of businesses, organizations, and other constituents. With SJDA, I helped develop an onboarding for new businesses, setting agency highs in grand openings, and organized one of the three downtown committees. Within two years' time I helped activate the previously dormant Historic District, growing the monthly business attendance to double digits, while supporting over 50 businesses with Grand Openings, Ribbon Cutting Ceremonies, and small-scale marketing. The ability to drive relationships and process is what I would tap into as an active Charter Review Commission member.

What is your understanding of the purpose of the Commission?

My understanding is that the Charter Review Commission was established to examine the City's governance structure for efficacy, accountability, and to ensure a representative government. The commission also serves as an advisory committee to the City Council, and can directly, or indirectly, support citywide efforts to improve accountability, representation, and inclusion within our beloved City. Beyond that, an Art Commissioner role should be an opportunity for ambassadorship across across the creative sector, and an invitation for continuous improvement and accountability from our dear city.

(1) Having a more inclusive and streamed lined application process, as well as improved community engagement to solicit underrepresented candidates. I've directly supported several grassroots and agency based community engagement initiatives. I'd like to support these efforts if and when it is needed. (2) Pairing with local businesses, organizations, and cultural institutions to have community engagement best practices embedded within governance structure and charter amendments. I've held several partnership roles, enabling a large reach on a variety of City-based constituents. I'd like to leverage relationship building and my network to serve the Charter Review Commission to my best ability. (3) Improved social media presence and social media campaigns to activate a variety of platforms, increase Chater Review visibility, and to engage diverse age groups (such as millennials and Gen-Z). I've supported communications for several organizations and boards and could apply this practice as needed.

Borca produced the event in collaboration with San Jose Jazz and the School of Arts and Culture with funding from San Jose's Abierto program. 3) PRODUCER of Colour Me GOLD: A music and art series intended to celebrate BIPOC creatives, small biz, and producers. This show and the two to follow are in partnership with existing or currently dormant historic venues that have an outdoor patio, and indoor space (Mosaic Restaurant and Lounge, Five Points, Hotel De Anza - Hedley Club) and will be free (donation based) to the public. Every event will feature a musician, artist, and local small biz or bar that has stopped showcasing music since the pandemic or has had to change their model to sustain their business. The idea is to support our local ecosystem, small biz, and to feature incredible creatives, all the while creating and EXPERIENCE for patrons.

I truly believe in the power of the arts to propagate a more equitable, just, and vibrant society. The creative sector (including music), can be accessible forms of expression across cultures, demographics, backgrounds and lived experiences. I think it's imperative that we lean into our DEAI (Diversity, Equity, Accessibility, and Inclusion) values now more than ever. In other words, art can be the vehicle to invest in, uplift, and celebrate the diversity of our creative sector and community.

Should the City of San José have an active role in arts and cultural development? If so, in what ways and why?

Absolutely. As a champion/ambassador of the creative sector, my story is very much an example of how my trajectory was transformed through performing arts and music. Growing up as a 'troubled youth' in East Side San José, my single-teenage mother and nana (grandmother) tried many things to help easy my temper and to channel my energy. It wasn't until my mother introduced me to writing (music and poems) that I had a framework and outlet to better understand my lived experiences. I didn't always have the model examples that I needed, but I never had a deficit in love. I now try to model the many identities that I carry and the hats that I wear all at once. I hope to help change the narrative of what it means to be human in a professional world, even if that means not fitting squarely into any one identify, and hope this inspires people to bring their full selves. Our city should populate boards and commissions with diverse perspectives and continue to invest in the local creative sector. More equitable representation at decision making tables, like civic commissions, and boards will serve our city-wide, and diverse-makeup. I also know well need local government and elected officials to support equity-based initiatives for our creative community (like DEAI workforce development programs). Lastly, I believe that our city could really spur cultural development, such as investing in art and culture organizations to steward Cultural Districts, and to honor place-keeping or place-honoring.

How can you contribute to advising City Council on policy and programs related to cultural development in San José?

I feel that I am in a unique position to add to the conversation on advisement because of my role as Deputy Director, and because of our plans to acquire property and to champion a cultural district in Mayfair (but also in Japantown and SoFA). I'd be happy to leverage my leadership and our resources to hold conversations as it relates to cultural development. Because of our city owned facility (6 acres), familiarity with city/county mandates, we'd also welcome hosting meetings or events that could be a resource as a physical (safe) space. I'd also stay committed to my network and community as a role of commissioner and commit to community engagement. This would be a value add because I am in many networks, and model a strong ethics and commitment to community building as a performing artist, producer, curator, and advocate across disciplines. While I have select involvement with civic engagement, I am also pushing myself to be more involved in fundraising and supporting local elected officials. This is my way to leverage my nonprofit background with long-term and sustainable change.

Anything else you would like us to know?

For the better part of a decade, I wrote many chapters, grew my skillset, and gratuitously had space to fail, all supporting my growth as an intentional, creative and compassionate leader. I believe the most important chapters of my career are still to be written. From upholding stakeholder relationships to driving programmatic goals, along with a body of work supporting community initiatives, I often ruminate on moving the needle for the City that I was homegrown in. A proud Mexican and Filipino, East San Jose product, I hope to serve my City and see the Charter Review Commission as strong avenue to do so. I appreciate the opportunity provided to me by the city council to serve on the planning commission and have enjoyed contributing to the betterment of our community. I am willing and able to continue with both the responsibility and time commitment going forward. During my planning commission tenure, I missed one meeting. In 2019, I arrived ten minutes late due to heavy commute traffic from Redwood City and this same meeting was adjourned as I arrived due to no significant agenda items. Coincidently, this is small example on the impact of the jobs/housing imbalance which forces the majority of employed residents (pre-pandemic) to leave San Jose daily for employment and thus residents are less likely to participate in civic affairs. During my time on the commission, I have consistently supported professional planning staff and our established city goals by voting for all projects which had the support of planning staff. This includes affordable housing, market rate housing, commercial, industrial, and conditional use permits. Planning staff recommendations follow the General Plan and/or pertinent Specific Plan/Urban Village and the commission works to implement policies established by the city council. On more than one occasion, I have had the opportunity to provide historical context on several applications that have been under consideration for 10 to 20 years and the city council ultimately supported those same projects unanimously. I have also supported professional planning staff by ensuring land use applications are processed without delay so the city council has more options to schedule city council hearing(s). In the past, prior planning commissions delayed agenda items unnecessarily which ultimately impacted the city council with limited calendar options or having to endure a really long council meeting to meet state deadlines. I periodically express, as needed, the distinction between commission's narrow scope of responsibility and city council's vast latitude and flexibility. I have shared that only the city council can create new ordinances or implement creative out of the box solutions for contentious land use items. I have completed all AB1234/AB1661 trainings, filed all FPPC forms consistently, and attended American Planning Association conference virtually last year. I also follow guidance from city attorney regarding brown acts and as directed by the city attorney to not attend interest group events meant to persuade commissioners. Prior to serving on the planning commission, I reviewed countless land use entitlements across the entire city, listened to hundreds of hours of testimony, and attended community meetings in every council district. I believe a good planning commission is a strong asset to any city, since proposed projects that implement a modern General Plan often have significant community opposition due to increased densities, heights, traffic, and reduced parking requirements. Having a planning commission which is knowledgeable and implements the city's goals enables the city council to have a smoother process with public hearings. From my first hand perspective, I have found citywide representation on the planning commission to be positive the same way it has been for the city council. The discussion from fellow commissioners has been thoughtful and respectful. I also believe web meetings have allowed more residents to participate during public hearings and has also enabled higher attendance from commissioners that has avoided cancelling meetings due to lack of quorum.

Born and raised in San Jose, as the son of immigrant parents who were both teachers. My Mother taught Italian at community centers and public schools while my Father taught adult immigrants to speak English at churches such as St John Vianney and Sacred Heart. Our family lived in an apartment for approximately ten years before my parents bought their first and only home. I mention this for background to share our family is of modest means and understands the immigrant experience which is an immense strength for San Jose. Neither I, nor my family, have any financial interests in real estate besides our respective primary residences. I served as member of General Plan 2040 Taskforce (four years) and General Plan 2040 Update Taskforce (approximately 1 year). Currently, I am keenly interested how local government through land use could further support elder care for seniors and make certain that government proceedings and the associated documentation are accessible for everyone, including the disabled community.

Jobs-Housing-Environment: The Planning Commission does not control what applications come forward as those are initiated by private property owners and in limited cases government entities. The Planning Commission must act within federal/state law and city ordinances. Adherence to San Jose 2040 General Plan, Specific Plans, and Urban Villages should be respected. The City of San Jose has had a documented jobs housing imbalance since at least 1976 as proclaimed by then Mayor Janet Gray Hayes. The 2040 General Plan has a goal of preserving industrial and commercial land so as to provide a tax base to pay for city services and provide reasonable commutes for San Jose residents. Deviation from General Plan goals should be deferred to the City Council. In addition, the City Council has adopted a plan for 25,000 units of housing, of all income levels, mostly in the center of our city. These infill housing units will include increased densities which are widely accepted as beneficial to the environment. As a District 3 Youth Advisory Council member, I worked alongside the past and current District 3 Youth Commissioners to bring attention to a myriad of topics, ranging from environmental preservation to implementing policies from other cities (The San Francisco C.A.R.E.N. Act). Objectives that I would work towards as a board member are policies regarding the environment and civil/youth engagement. Furthermore, with my past experience in the District 3 Youth Advisory Council, I want to create policy proposals and memorandums that focus on marginalized youth specifically. Black, indigenous, youth of color and underrepresented communities make up the heart of San Jose and District 3. I believe that representation from our marginalized perspective—as a daughter of Vietnamese refugees living in a historically redlined neighborhood—would help change the policy agenda to focus on the historically underrepresented. I want to be the representation I wanted as a child. I want to advocate for Black, Indigenous, People of Color (BIPOC) and represent our communities of color and change as a diligent, hard-working representative.

I joined the YAC in 6th grade and helped the past Commissioner Maren Bick-Maurischat spread awareness about the Youth Commission. Alongside former Commissioner Bick-Maurischat, we attended and advocated for youth at town halls, hosted monthly Youth Advisory Council meetings in the Roosevelt Community Center, and held a community movie night before the pandemic. In the past couple years with current Commissioner, Nicole Hoang, I worked alongside them to draft and write seven policy proposals with the purpose of bettering the environment, mental health, and racial and gender inequity. These policies were all recently approved on the Youth Commission's February General Meeting agenda. One specific policy I can point to is the "PAC" policy memorandum. PAC is an acronym for "Public Access Computer," and these computers are in all San Jose Public Libraries. On a specific team with another YAC member and the Commissioner, I wrote a policy memorandum for all PAC to have "call to action" buttons where the public can easily sign up and register to vote on these Public Access Computers to encourage diversity. I am an avid advocate for voter registration. Votes matter to change our communities and create a better city, and I want to pursue further civic policy ideas in the future because a lack of civic engagement impacts marginalized communities the most. Currently, Commissioner Hoang's policy proposals are waiting to be signed by a fellow Commissioner before they are sent off to the District 3 Council Office. This year, I was elected as Vice-Chair of the District 3 Youth Advisory Council to lead D3 YAC initiatives and outreach. I worked with Commissioner Hoang to organize the short meeting that the D3 Youth Advisory Council had with the D3 Council District Office. There, we discussed and learned about the process of how an idea becomes a policy memorandum, and eventually an implemented policy. I also helped in the creation of the annual policy survey in 2019, and now, the survey has merged with the San Jose Public Library's mental health survey and is at 400 responses. With Commissioner Hoang, we are planning to host a policython to teach youth how to write policy memorandums to be more civically engaged. As this year's vice-chair of the District 3 Youth Advisory Council, I headed a lot of outreach initiatives to get youth involved in the Youth Commission's events and checked up on other members to make sure their policy writing tasks were completed. One such example was the promotion of the annual San Jose Youth Commission Budget Summit, and another is my current promotion of the annual Youth Commission survey. In one paragraph, please explain your community interests.

My community interests involve bettering the environment through policy proposals. As a part of the YAC, inequalities in housing and income were brought to my attention. Gentrification became a monthly discussion, and youth civic engagement in voting accessibility became a hot topic. With the current Youth Commissioner and other Youth Advisory Council members, many of these policy memorandums helped address those inequalities while communicating other ideas to focus on as a city, ranging from racial equity, sustainable architecture, and mental health.

What do you feel are some of the problems facing the youth of San Jose?

Unequal and lack of housing is among one of the greatest challenges youth in San Jose face. Without proper housing, youth are constantly facing issues outside of the stress school brings. As a student attending a school in which the majority of students are non-white, I noticed that there weren't that many opportunities that were spread out. Most of the time, people received information by personally seeking it out instead of having helpful organizations such as the Youth Commission promoted. Because of this, there is a lot of lack of civil engagement and diversity in local politics from youth. Lastly, the environment is another issue that youth face in San Jose. Climate change will affect my generation, and if appointed, I want to continue pursuing policies that address sustainable practices, such as sustainable architecture, strategic deconstruction, and more from other cities internationally.

What do you feel the priorities of the Youth Commission should be?

The priorities of the Youth Commission should be to promote pre-existing local/city resources to youth, to encourage diverse youth participation in local government and elections, and to focus on the environment and our city's sustainability with the current Climate Smart San Jose Plan. The City of San Jose already has many resources for youth and marginalized communities, such as a master document on housing resources. I believe that the Commission should focus on promoting such information to engage more youth and build a relationship of trust between youth and local government. As for diversity, I believe the Commission should be more energetic in its focuses to target marginalized youth. In the past, the Youth Commission has led budget summits where youth advocated for their priorities regarding city departments. For this year's Annual Budget Summit, the current Commissioner and I both outreached to our friend groups and classmates to diversify the participation in the budget summit; as a result, working youth, more youth of color, and more youth from traditionally "unreached" communities were brought to the budget summit. Furthermore, I believe that the Youth Commission should have closer relations with their corresponding Council District Offices. I know that the current Commissioner for D3 is working more closely with their Council District Office to discuss policy memorandums and how their goals align with the Council District Office's goals. I believe that this type of synergetic relationship should be pursued by the entire Commission to forward their policy goals and communications with our local government. Additionally, in Youth Commission meetings and town halls, the environment and housing were some of the highest priorities, and I believe we should follow through with our youths' priorities.

I helped draft several policy memorandums regarding the environment, racial inequity, and gender inequity. Additionally, I helped facilitate monthly D3 Youth Advisory Council meetings in which we had an open discussion about future policy ideas and events. I also help write the agendas and use creative slide decks for our monthly Youth Advisory Council meetings to further engage my peers. In terms of specific policy delegation, I have been responsible for touching base with fellow members on their roles and responsibilities.

With the experience of being the District 3 YAC Vice-Chair, I began to understand the role local youth and the Youth Commission had on the well-being of the city and people. With Commissioner Hoang and the District 3 Youth Advisory Council, I started developing my communication skills by discussing with others and participating in Zoom meetings that addressed budget priority and the passing of policies. I grew my skills in teamwork and learned how to effectively reach out to others in and outside of the council, and worked on my organization skills. Finally, from both my school involvement in Speech and Debate and my current position of Vice-Chair on the District 3 Youth Advisory Council, I have built my leadership skills by honing in on policy responsibilities and working with a fellow member (Amelie Pak) to create a streamlined financial literacy curriculum to send to the Mayor's Gang Prevention Task Force for their Santa Clara County partners.

The San Jose Youth Commission is a city advisory board made of 11 youth members that advise the Mayor and City Council on youth priorities, policies, and other issues and initiatives. The Youth Commission also serves as the main conduit between youth and their local government through Youth Advisory Councils, Town Halls, Budget Summits, and the annual Youth Commission work plan that addresses both social issues and policy issues within the City of San Jose.


