I am a board member for the United Lowrider Council of San Jose and a business owner in the City of San Jose. I am writing to ask that you eliminate the regulation of cruising from the San José Municipal Code, an action proposed by Councilmember Raul Peralez.

The current ordinance that prohibits cruising in San José is an antiquated policy rooted in discrimination and racism against the Chicano culture. I have long been a victim of being racially profiled for simply driving my car in the cruising zones. During the countless times I was pulled over for "cruising," I was not issued a citation of any kind for breaking the law. Within the past decade, this policy hasn't been enforced and no citations have been issued as the city is now battling a new pressing issue that the lowrider community is not in support of, sideshows. By eliminating this ordinance, we can refocus our resources toward the sideshow problem we've now inherited from neighboring cities such as Oakland. The folks in the lowrider community strongly oppose sideshow activity and we always ensure that we present a safe environment by driving slow. Furthermore, the culture of cruising aligns with the city's Vision Zero goals towards slower and safer streets.

There are many cities that have already eliminated this ordinance such as San Francisco, CA and Sacramento, CA and the city council members in Sacramento already unanimously voted to eliminate it. For folks that are unfamiliar with the Lowrider culture, San Jose has strong roots to this culture as Lowrider Magazine was founded in San Jose by Sonny Madrid in 1977. Lowriders participate regularly in community driven events such as toy drives, feeding the homeless and participating with local non-profits to continually uplift the city of San Jose. The culture itself is an enriching and vibrant one to the city of San Jose.

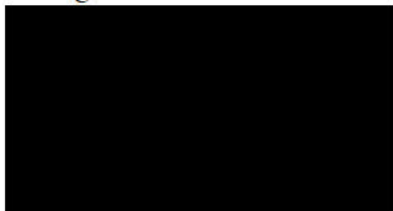
