Of the 23 proposals received, staff determined that four (4) did not meet the submittal requirements and/or minimum qualifications specified in Sections 3, 4, 9, and 10 of the RFP. An evaluation panel scored each of the 19 qualifying proposals against the criteria and weightings specified in Section 4 of the RFP, which states that successful consultants will score above 60 on the criteria.
