RECOMMENDATION

Set a Joint Meeting between the City of San José Public Safety, Finance and Strategic Support Committee and the County of Santa Clara Public Safety and Justice Committee regarding coordination between the City and County on mental health crisis response and pretrial release of arrestees on <a href="https://doi.org/10.100/justice-neeting-nee

BACKGROUND

At the April 27, 2022 Rules and Open Government Committee meeting, Mayor Liccardo, Councilmember Carrasco, and Councilmember Mahan brought forward a memorandum entitled "Addressing Rising Crime & Exploring Treatment for Arrestees in San José." This memorandum proposed directing the City Manager to participate with the Mayor and key stakeholders from other agencies to address the public safety challenges posed by high rates of recidivism and methamphetamine addiction among arrestees that are released pre-trial in Santa Clara County. In response, the Rules Committee directed staff to work with the County to organize a joint meeting between the City's Public Safety, Finance and Strategic Support Committee and the County's Public Safety and Justice Committee for the purpose of discussing the issues raised in the memorandum from Liccardo, Carrasco and Mahan. With this memorandum, staff is proposing to set a joint meeting with the County that will satisfy the Rules Committee's direction.

PURPOSE

The purpose of this meeting is to facilitate a discussion regarding coordination between the City and the County on public safety and criminal justice matters of mutual interest and concern. The meeting will start with a brief overview of the roles of the City and County in the criminal justice

system, and then will proceed to detailed discussion of two topics. First, the committees will receive a report on mental health crisis response, with an eye to identifying ways that the City and County can continue to improve the coordination on this topic. Second, the staff will provide a report on the pretrial release process in Santa Clara County, with a focus on clearly identifying the roles of various agencies in this process and identifying opportunities to pursue process or policy improvements. Finally, the committees will have an opportunity at the end of the meeting to discuss next steps and identify opportunities for future collaboration on the topics discussed.
