BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Children of the Rainbow Park National Night Out event was hosted on August 12th, 2022, at Children of the Rainbow Park. This special event invited community members to foster community by convening resource tables, games, and activities. The Mayfair Senior Yoga event was hosted on August 18th, 2022, in the Mayfair Community Center. This special event allowed for senior residents to practice yoga. The Hillview Library Reclaiming event was hosted on August 20th, 2022, at Hillview Library. This special event invited community members to heal and foster community by convening community, resource tables, entertainment, and activities. The SV PRIDE Parade was hosted on August 28th, 2022, in Downtown San José. Theis special event celebrated Silicon Valley's LGBTQ+ community. The four events were free, open to the public, and sponsored by Councilmember Magdalena Carrasco

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Magdalena Carrasco will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 5, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
