

Park Context





Naming the Park

City Council Policy 7-5, Naming of City-Owned Facilities Names must align with the following policy criteria:

- A geographic location
- Prominent geographic feature or local reference point
- An adjoining subdivision or community
- A historical event
- An individual who has been deceased for at least five years
- An individual via a donation or sponsorship agreement; or,
- A group via a donation or sponsorship agreement

Results of the 3rd Ranking Survey

Answer Choices	Responses	
Hanchett Park*	42.37%	25
The Alameda Park	33.90%	20
Shasta Hanchett Park	23.73%	14
	Answered:	59

^{*}After the survey closed a community member expressed concern the name "Hanchett Park" might have implications that don't align with the City's commitment to Racial Equity. As a result, staff researched the history related to the name "Hanchett." This research did not conclusively confirm or eliminate concerns.

Recommendation

- (a) Adopt City of San José 1343 The Alameda Master Plan Report for a new public park.
- (b) Adopt "The Alameda Park" as the official park name as recommended by staff and the Parks and Recreation Commission and as a result of a public outreach process.

Survey respondent's claim regarding Lewis E Hanchett:

The name. Hanchett was a racist and my deed along with everyone's deeds have exclusionary verbiage that would not allow black people to buy into the development. I like the idea of the park but a group of neighbors will likely sue the city over the use of the name Hanchett.

Respondent's reply to survey question #4:

"If you could change one thing about the plan what would that be?"

Research Conducted on Lewis E Hanchett:

- Contacted survey respondent for clarification and a sample of their deed
- Reviewed original deeds for properties along Martin Avenue in Hanchett Residence Park
- Researched and reviewed historic articles on Lewis E. Hanchett
- Spoke with experts on the history of LA's Union Station
 - 2 historians from USC
 - 1 President of the Chinese Historical Society of Southern California

Results of the Research:


- Research was inconclusive
- Neither confirmed nor eliminated concerns

Implications of the Research:

- Concerns remained
- Name may not align with the City's commitment to Racial Equity
 - Resident Parks were "characterized by their Conditions, Covenants, and Restrictions" (CC&Rs)
 - Neighborhood became exclusionary under Redlining in 1937
 - Hanchett bought up land in LA's Old Chinatown, likely leading to displacement of Chinese Americans (1914)


Recommendation by staff:

Consider the next highest ranked name, "The Alameda Park"




- Area around the park was redlined
- Hanchett Resident Park was graded "still desirable" and exclusive

The City of San José has a naming policy to guide the naming of public land and facilities. This revision updates the criteria and process to be used in considering the naming or renaming of public land and facilities, other than City streets, which is covered in City Council Policy 6-5.

PURPOSE

To establish Council policy regarding the determination of names to be given to City-owned land and facilities that are not City streets.

POLICY

It is the policy of the City of San José to determine names for City-owned land and facilities after following the procedures set forth herein.

It is the Policy of the City of San José to encourage:

- Naming which reflects the City's ethnic and cultural diversity;
- Recognition of distinct geographic, environmental or developmental features, or names of historical significance in naming City lands and facilities;
- Recognition of individuals who have made a significant contribution to San José, the State, the Nation or the World;
- 4. Naming as early in the capital planning and development process as possible; and
- 5. Sponsorship through significant funding support from private donors for the construction and/or ongoing maintenance and operations of City lands and facilities in exchange for naming options. The minimum sponsorship or donation amount necessary to achieve the level of significant sponsorship or donation shall be determined by the responsible Department's Fundraising and Sponsorship guideline as approved by the City Manager, unless otherwise approved by City Council.
