<u>Purpose:</u>	To represent the City of San José on the visit to Amsterdam, the Netherlands for the CityLab 2022 conference, hosted by the Aspen Institute and Bloomberg Philanthropies.
	I will be speaking on the Mayors Innovation Studio panel on Sunday, October 9. This is an exclusive day-long event that provides mayors from around the world with an opportunity to congregate and discuss innovative strategies and ideas. The workshop will focus on the future of city centers, convening mayors with subject-matter experts, equipping city leaders with tools and tactics to foster inclusive growth, diversity local economies, and re-invent their city's downtown and commercial districts.
	The importance of attending—particularly with Deputy City Manager Rob Lloyd—is to provide a "clean handoff" to City staff for San Jose's continued engagement and participation in the network created by Bloomberg Philanthropies. The City's ongoing participation in the Bloomberg Philanthropies network has yielded considerable public benefit with various environmental (i.e., Climate Cities Challenge,

> which provided more than \$3 million to the City of San Jose in funding and staff to implement ground-breaking all-electric building and parking reduction policies) and smart city (e.g., data and technology) initiatives.

> Clay is the Chief Innovation Officer and Senior Technology Advisor on the Mayor's Office of Technology and Innovation, and has been working closely with key staff in the City Manager's Office to further the City's tech and innovation initiatives.
