BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Noble Elementary School Fall Festival will be held on Friday, October 21, 2022 at Noble Elementary School, 3466 Grossmont Drive, and is sponsored by Councilmember Cohen. This special event provides residents with an opportunity to gather and enjoy games and activities in a safe, and family-friendly environment. The event is free and open to the public, and will follow all appropriate local public health rules.

The District 4 Pumpkin Giveaway will be held on Wednesday, October 26, 2022 at Brooktree Elementary School, 1781 Olivetree Drive, and is sponsored by Councilmember Cohen. This special event will provide residents an opportunity to gather in a family-friendly environment,

receive free pumpkins and enjoy activities. The event is free and open to the public, and will follow all appropriate local public safety rules.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Cohen will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 4, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
