WHEREAS, an automated exit lane in Terminal A will improve safety and security at the

Airport ("Terminal A Exit Lane Project") and would fit within the criteria for potential BIL

ATP grant funding; and

WHEREAS, the BIL's ATP will provide reimbursement of 80% of eligible Terminal A Exit

Lane Project costs to the Airport; and

WHEREAS, applications to the FAA for ATP grants are due in October 2022 for Federal
