

### 2021 International Building Codes





### What Does the Proposed Ordinance Accomplish?

- Adopts the 2022 edition of the California Building Codes with amendments
- Updates previously adopted local amendments to the 2022 California Codes to match current code language and cross-references
- Updates the San Jose Municipal Code (SJMC) to eliminate local amendments that have been incorporated into the 2022 California Codes



#### Title 24 Building Code Amendments

- Retain:
  - Four (4) amendments to 2022 California Building and Residential Codes
    - Building separations
    - Special testing & Inspections
    - Gypsum board shear walls
    - Braced wall panels
- Additional amendments:
  - No additional (0) amendments to 2022 California Building Codes



#### Title 17.12- 2022 California Fire Code (CFC) Amendments

- Repeal: Nineteen (19) amendments:
  - 3D printing operational permit, definition, manufacturing requirements (3)
  - Combination standpipe/sprinkler prohibition (1)
  - NFPA 13, 13D, 13R, 14, 20, 24, 72, 1221 Standards (8)
    Revert to standards in 2022 CFC
  - NFPA-19 13, 13D, 13R, 14, 20, 24, 72 Standards (7)
    -Revert to standards in 2022 CFC



### Title 17.12- CFC Amendments

#### Modification: Thirty-One (31) amendment modifications:

 Amendments were modified for minor clarity corrections and long-term policy codification

#### Additions: One (1) additional amendments:

- Inspection, Testing and Maintenance Requirements-Addition of requirement to notify inspection compliance service contracted by the City of San Jose
- Retain: Eighty-Five (85) retained amendments



### Title 17.68- Hazardous Materials Storage Permit Amendments

Modification: Seven (7) amendment modifications:

- Amendments were modified for minor clarity corrections, utilization of 2022 CFC definitions, and removal of invalid legacy notification requirements.
- **Retain:** Seventy-One (71) retained amendments
