RECOMMENDATION

- 1. Approval of the Santa Teresa Dumpster Day held on Saturday, November 19, 2022, as a City Council-sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on the November 15, 2022, Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council Council-sponsored Events and the proposed use of any funds.

The District 10 Council office is working with the neighborhood associations in the Santa Teresa/Bernal area to plan a Dumpster Day on Saturday, November 19, 2022. Volunteers from these neighborhoods will be helping to direct traffic and connect with residents. The District 10 office will provide dumpsters, taking advantage of the \$18,000 budgeted in the FY 2022-2023 Operating Budget for community cleanups and dumpster days throughout District 10. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Mahan will report any cash or in-kind donations received for the
