Honorable Mayor and Council,

I am a recent former employee of the City of San José, who served as Chief of Staff to Councilmember Perez in the District 3 office. I am requesting a waiver of the Revolving Door Prohibitions policy under Chapter 12.10.070 so that I can continue to serve the residents of San José and partner with the City of San José on critical issues regarding power, infrastructure and emergency services in my new role as Sr. Government Affairs Representative for Pacific Gas and Electric, Inc.

After 7 years in the District 3 office, Councilmember Perez's term is coming to an end, therefore I was offered a position to continue to serve residents within the San José area and throughout the County, which began October 31, 2022.

As Sr. Government Affairs Representative I plan to work with City Departments and City elected officials on issues that play a vital role to the residents we each serve. The City's Revolving Door ordinance would prohibit me for two years in working with the city on crucial matters that are part of my job responsibilities including:

- Emergency liaison with cities and emergency managers
- Support to emergency operations
- Public Safety Power Shut Off Responses
- Wildfire Response
- Liaison to infrastructure projects and issues

According to the policy under Chapter 12.10.070 the City Council may waive the Revolving Door's Ordinance's two-year prohibition, "if the council or board finds a waiver is in the best interest if the city or agency." I believe that the purposes stated above are consistent with a waiver and would allow me in the current capacity as Sr. Government Affairs Representative at PG&E to support the city and the constituents of San José.
