BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 4 Pajama Giveaway was held on Monday, December 12 at 1376 Piedmont Road. The purpose of this event was for San Jose residents to gather, socialize and receive free pajamas for children. This event was free and was open to the public.

The River Oaks Neighborhood Association Meet and Greet will be held on January 18th at the Elan at River Oaks Apartments Community Room. This event will provide an opportunity for District 4 residents to share their concerns about their neighborhood and issues facing the city, as well as to get to know their Council Member and receive a Council update. This event is free and open to the public.
