My understanding is that the City of Santa Clara owns their own. Santa Clara residents have lower rates. I'm also aware of cities that have toyed with the idea. PG&E service improved as a result. Quality life issues are important to District 10 residents. One example, our councilman was able to get the trees trimmed along the Los Alamitos Creek Trail. The residents in District 10 were grateful because it made the trail safer and more accessible for all who used it.

I want to assist District 10 by solving public safety issues and ensuring that we have a strategic plan in place to improve infrastructure, including utilities for the City of San Jose.

First, I would like to thank each of the council members for their diligence in this appointment process. I truly appreciate their commitment to public service and to the residents of San Jose. Also, I would like to thank the many qualified applicants who have stepped up to offer their service to our great city. I'd like to tell you a little more about me so you can better understand my passion for public service. After receiving a business degree in my 20's, I worked for a large company, ARA Services, and began moving up the corporate ladder. They moved me to the Bay Area in 1983 as a Regional Marketing Manager, I was chosen to head the Junior Achievement Program for the company. While in that position, I had the pleasure of working with High School teams to create and market products. I also took Dale Carnegie courses and was trained as a teacher of Dale Carnegie. This experience had a profound affect on me and vastly improved my interpersonal skills. I still employ Dale Carnegie communication techniques whether talking to one person or in groups. I believe my active listening skills helped me earn the respect of attorneys and their clients in court. I was honored to earn the 2005 Judge of the Year award (out of 80 Judges) in only my third year on the bench, voted by the Trial Lawyers Association. But aside from Junior Achievement and Dale Carnegie, corporate life was not fulfilling. I wanted to work with and help people all the time as I did with Junior Achievement and teaching Dale Carnegie, not sell people. I left the corporate job at aged 30 and followed a lifelong dream to go to law school. After my first year, I was grateful to be selected to intern at the ACLU specifically to help fight an initiative to mandate guarantining of AIDS patients. Next, I gained experience at a Public Defender's Office learning how to respectfully represent indigent defendants. Both experiences brought out the passion I was seeking. As a lawyer, I acquired more than a decade of experience as a DDA where my passion focused on gaining justice for victims of crime. In 2003, I was honored to gain the support of judges, attorneys on both sides, every San Jose council member and community groups in my successful election to the Superior Court. I loved being a Judge, but my Drug Court assignment was like no other criminal law experience, as now being an expert on crime wasn't enough. I was dealing with the homeless, drug users, and the mentally ill on a daily basis. I needed to do everything I could to become knowledgeable about these individuals and the issues they faced. I listened to the people who came to court to understand them better so I tailor a sentence that focuses on treatment and recovery. I learned and studied everything put out on homelessness by experts like Phillip Mangano, the Drug Czar for Presidents Bush and Obama. I visited Job placement facilities, homeless camps and treatment centers. I enjoyed attending drug graduations for my successful folks and was honored to receive positive feedback in the MN after one particular graduation. Since retiring, its been difficult watching the surging crime in the city. People are angry and afraid. They feel that there is no one to protect them and that criminals and car racers own the night. I've been active on Next Door and in our district trying to counsel people on how to stay safe and not become victims of crime. but I want to do more. Also, the homeless problem is heartbreaking. I know from my experience that it is a complex problem, but there are solutions to reduce the number and put a roof over the head of most of them. I have solutions for what blight we have in D10, to me that's the easiest issue to tackle. I love my city. I am the passionate about the issues facing our city and I believe I have knowledge gained from real world experience that will help us find solutions. I would be honored to work with the San Jose council members to improve the quality of life for every San Jose resident.

Most of the commission and board meetings that I have attended consisted of budget information, initiatives and event planning. However, I had the wonderful opportunity to serve as a Commissioner for our Sister/County Commission: HSINCHU COUNTY TAIWAN/ SANTA CLARA COUNTY. I attended the meetings and enjoyed all the members without exception. Supervisor McHugh and I led a delegation of commission members to HSINCHU COUNTY and toured around the entire island by bus, singing Karaoke between stops. We visited 7 cities and were greeted by dignitaries each time. We exchanged gifts each time and and the 10 course lunches were very filling. Visiting a technology park was very interesting. Because I was a Judge, I was honored that they allowed me to sit on the High Court as an Honorary Judge and wear their robe. We commission members, made up mostly of Taiwanese Americans loved each other's company and continued to get together at our homes for pot lucks after our service.

While on the bench, I stayed very active in the San Jose community so that I could better serve the many diverse ethnic groups that appeared in court. I believed that "tolerance" should no longer be the goal, but instead we should be striving to "embrace" each others cultures as I do with my district 10 neighbors. With that goal in mind, I joined the Kiwanis Club of San Jose, where we served the underprivileged. My favorite memory was providing children with bicycles and other things that were normally unaffordable. Later, I decided to join the Rotary Club, where we again did volunteer work in the community, including serving weekly dinners at the Julian Street Inn. I was honored to be asked to join the advisory board of the Viet Heritage Society. As a part of my duties, I interviewed and helped select summer interns for the nonprofit. Similarly, I was chosen by the Hispanic Foundation to review applications for scholarships and choose recipients. One of the more intensive and rewarding acts I had the honor of performing was Former Mayor Ron Gonzalez's "Role Model Program". With student course books in hand and a teacher's manual, I taught a class at Peter Burnett Middle School designed to show underprivileged children the path to rewarding careers. Careers that almost all of the students thought were unattainable to them. This hit close to home for me, the son of a single parent who thought that working at the local factory was my only option. I also served as a board member of the Boys & Girls Club of Silicon Valley, and participated in their activities. I have volunteered feeding the homeless and both the Second Harvest Food Bank and Martha's Kitchen. I believe my extensive interaction with our diverse community as well as my job experience makes me uniquely gualified to work with council members to find lasting solutions that face our city today.

I believe the greatest issue that the City of San Jose faces is improving the quality of life of its residents. We live in an area of California that has so much to offer and yet people are leaving our city in large numbers. The cost of living has become so high that working class people can no longer provide the life that they want for their families and because we are losing residents at such a high pace, almost every employment sector is understaffed. This exodus erodes the city's tax base and if people can not thrive in our city then neither can our businesses. As a city government, it is important to focus on ensuring that the infrastructure is in good working order. The City needs to make sure that there is plenty of affordable housing and that there are collaborative solutions to unhoused encampments. It is also critical that the public feels and is in fact safe in every way from fire, crime, and traffic incidents. The City is also responsible for ensuring that our roads and public spaces are in excellent condition and that our environment is healthy for all residents and their families. There is so much work to do and we need to do it in partnership with other entities like the County of Santa Clara. The City of San Jose has recently partnered with the County of Santa Clara around the Single System of Care Initiative. This work helps our residents navigate the complex systems that affect them within the County and the City. It is a very efficient way to work together on behalf of those we represent. I can imagine if this partnership finds further success there will be other opportunities where working together benefits all of us.

District 10 residents are very engaged community members who care deeply about the quality of life in the Almaden and Blossom Valley region of San Jose. The D10 area includes wonderful schools, libraries, community centers, parks, lakes, trails, wildlife, and green spaces. Many neighborhood associations are committed to not only ensuring that their community spaces are beautiful but also spend time making sure neighbors are connected to each other. There are quite a few issues of residential concern including unhoused encampments, public safety, and blight. D10 residents are also concerned about the cost of living in our city as many would like to see their adult children able to afford the ability to purchase a home and raise their grandchildren in the area. As homeless encampments are an issue that we all must work together to solve, I am deeply concerned about unhoused children and their families. It will be important that every district in the City do its fair share in supporting affordable housing and D10 is no different. If we look at creating affordable housing near our VTA transportation center as well as co-locating child care within housing we are making the very best decision that will support our city for years to come. One issue around public safety that should be highlighted is around traffic activity. Although building our elementary, middle, and high schools within 10 blocks of each other has been very efficient, it also causes concerns around traffic and accidents in our neighborhoods. In fact, a Bret Harte Middle School crossing guard was just hit by a car and sent to the hospital. Although the crossing guard did not sustain life ending injury, the danger still exists and I hope to work with the community to proactively address these types of accidents. The City of San Jose's Vision Zero Action Plan has lifted up ways to mitigate traffic accidents like these around schools. However, both Almaden Expressway and Blossom Hill Road have been identified by the city as roads that account for a high proportion of fatalities and severe injuries. We see the portable signs to slow down so as not to create more fatalities but we will need to implement more of the plan. D10 resident engagement in the Vision Zero Task Force can not only prioritize traffic enforcement but we can work together to create other risk reduction strategies and communication plans that work best for the unique issues occurring on our city streets. Another element of public safety I want to address relates to the recent Graystone fire. We must look ahead and prepare for the next fire season because D10 continues to be a significant risk for serious fire damage due to the composition of single family homes and large areas of green spaces. We cannot wait until the next fire is upon us. We need to be well resourced and prepared now. Finally, quality of life includes taking care of our environment. This means making sure our streets and creeks are clean. When I walk my dogs along the Los Alamitos Creek trail I can see there is more work to do to clean up trash, remove graffiti, and tow abandoned vehicles.

As someone who is already representing a large portion of the district as a San Jose Unified School District trustee, I have worked in support of this community for most of my career and most specifically during the COVID 19 pandemic. Families, most specifically parents, have brought extensive concerns to me regarding the pandemic, as well as several quality of life issues such as traffic safety, maintained parks, and accessible community centers. As such, I am interested in representing District 10 as a Council Member because I have a unique perspective that reflects our community's thoughts around the issues and concerns facing our neighborhoods and our city. I am interested in working towards securing a great guality of life for residents by improving our neighborhoods through responsive public safety, clean city streets, well maintained parks, healthy water and air, fully operating libraries and community centers, partnering with our schools, and being proactive around humane homeless encampment management. As a new appointee, it would be important for me to spend a significant amount of time in the district getting to know the residents and community on a deeper level to ensure I am bringing forward their concerns. I would prioritize working to ensure that we have a strong public safety plan in place and that the urgent issues in the district are managed in a timely and satisfactory way. I would also work on strengthening the programs that make a city family and child friendly. Strengthening the city's quality programming for children and youth is of utmost importance to me including continuing support of the Children's Bill of Rights, the Children and Youth Master Plan, and also creating an Annual Children's Budget. I would also like to prioritize continued investments in our child care provider system as well as working with our city's planning and building department to ensure that opening child care programs are not burdensome to these small business operators. It will also be important to me that the city continues to designate child care facilities within its own buildings, in affordable housing projects, retails spaces, public transportation spaces, and engages in partnerships with school districts for space. In addition to my role as a school board trustee, I am currently the Chair of the City of San Jose's Library Commission and

formerly the Chief Community Impact Officer for First 5 Santa Clara County. At First 5, I worked with our leadership team in securing child care for essential workers and for families caught in the gap, those who did not qualify for subsidy and could also not afford child care in order to go to work. I also led the charge on securing funding to provide \$10,000 awards for over 500 Family Child Care Home (FCCH) providers to continue to keep their doors open serving essential workers and later everyone else. Even still, over 350 of these women owned small businesses closed their doors forever. So in order to build more early education and child care workforce, I secured an initial \$5 million in funding to design and implement a set of child care workforce initiatives. These initiatives include: Early Education and Child Care Apprenticeship Program, Family Child Care Home providers Shared Service Alliance, and with the implementation of California's Transitional Kindergarten (TK) grade level, a TK Equity project in support of building more guality TK classroom Teachers. These programs have launched with great success and are in process of securing their second round of \$5 million in funding. During the pandemic at First 5, I also worked with our leadership team to secure funding from the City of San Jose and other government agencies to distribute over 3 million diapers, baby wipes, formula, and period products to our most deeply impacted community members. My work at the City of San Jose Library and Education Commission has been deeply rewarding and the level of community service our library system engages in is best in class. During my tenure we worked on so many initiatives but the work that was accomplished during the COVID-19 pandemic was particularly notable. Our library system led the way in supporting digital equity for our city residents and in particular our city's children. The amount of work done to implement broadband access, distribute hotspots and laptops, and ensuring digital library cards were available for everyone is to be highly commended. Our work to open back up fully and even expand the library's Sunday hours is of special importance as this is what the community asked for most. Finally, close to my heart is the work the library system has done to build a robust child care workforce program called Family, Friend, and Neighbor. As a leader at First 5 and one of the early investors in this work I have been very proud to see the amazing growth of this program. I am proud to see hundreds of people engage in these guality professional development opportunities. As a San Jose Unified School District Board of Education Trustee the work during the COVID-19 pandemic has been deep and wide. We not only had to completely move to synchronous online learning but we had to become an entity that manages the administration of healthcare monitoring of its workforce and students. The many operational change issues that needed to be addressed cannot be fully discussed here but I will highlight some of the most critical. The district work included the distribution of hotspots and laptops for everyone, feeding every student and family who were hungry, asking our bus drivers to do welfare and attendance checks, loaning out our nurses to the county to support the greater community, constructing safe physical spaces at schools and offices, ramping up significant mental health support structures, and managing through pandemic workforce burn out. Of particular note, we never lost sight of the district goal to improve quality of education through the implementation of our grading for equity initiative and the implementation of ethnic studies classes. I am most particularly proud to work with this group of elected officials collaboratively and successfully representing our students, families, and staff.

I believe that it is incredibly important that women are equally represented in all leadership positions where decisions are being made. The current makeup of our City Council includes only three women. Seeing this, I felt a call to action and have respectfully submitted my application for appointment. In addition to this, public policy should be created and legislated by those most affected by its implementation. Because of that, the lived experiences of our legislators matter. My experience as a single mom for over ten years living paycheck to paycheck and barely making ends meet taught me the importance of working for employers who put staff first. I was lucky that my employer subsidized 70 percent of my child care and even still I struggled. As I moved through life and met my future husband, who immigrated from Trinidad and Tobago at age 16, we focused on creating a strong blended family. We have been a family for 15 years and have been lucky enough to see our children grow and succeed. I bring all of these diverse life experiences to bear in all the decisions brought before me.

Whoever is appointed Councilmember will be held accountable by the voters of District 10, if they choose to seek election, just as Mayor Mahan will again face the voters in 2024. I pledge to work to earn the trust and support of the people I serve and to decide about the future in the future. I prefer to keep all options open so that the residents of District 10 know that they can count on someone at City Hall who is 100% committed to fully representing their interests and is dedicated to working with all facets of our community to solve the problems and improve the quality of life in our neighborhoods.

Public safety and providing effective services are among the biggest challenges facing San Jose. San Jose was once known as the safest large city in America. That level of safety was intentionally built on a community-based approach to crime prevention, intervention, and suppression strategies. I regard homelessness as a public safety issue because of the impacts on our neighborhoods and our unhoused residents. Solving our public safety challenges require collaborative solutions with neighbors, the County, community and faith-based organizations, and the state and federal governments. Providing and sustaining mental health and addiction treatment programs with assisted housing support is essential to address our homeless problems. To make San Jose a better city I believe a holistic view is needed to improve all city services - police, fire, code enforcement, parks and recreation, library, streets, and traffic, etc. We cannot expect improvement in the delivery of basic city services without solving the City's chronic inability to recruit, train, and retain employees in all job classifications.

The needs of District 10 residents are similar to the needs of all San Jose residents. District 10 today is not the same District 10 as many have perceived over the years. It is more diverse ethnically and socioeconomically. Through the redistricting process, District 10 has undergone significant changes – extending east and south of prior boundaries. The district now includes all the Blossom Valley and Santa Teresa neighborhoods south of Highway 85, extending south beyond Bernal Avenue. The common denominators are that we all want safe and secure neighborhoods, safe streets and access to affordable and efficient transportation, good economic and employment opportunities, sound land use planning, equitable and appropriate services for families, seniors, and persons with disabilities such as child care, good schools and after school programs, and the availability and timely response of quality City services when needed. The district will have had 3 Councilmembers in little over 2 years. A priority is to develop and grow the relationships between residents, the Councilmember, and City Hall. A significant effort is required to meet the challenge of bringing the neighborhoods together. As a Councilmember, it will be important to find the common interests throughout the District while also recognizing, honoring, and working with the unique strengths and needs of each neighborhood in the new District 10.

Much of my recent community activities have been as Chair of the D10-LC (www.sjd10leadership.org) and President of the SBSC (www.shadowbrook.org). Both organizations were in need of revitalization; the D10-LC's relevance was in peril as membership and interest was in decline. The SBSC was in need of a review of all operations. I am most proud of recruiting many new volunteers to serve on these two Boards as well as keeping them afloat during the COVID lockdowns. The D10-LC refocused at a grass-roots level working with the D10 council member and his staff. These more targeted initiatives resulted in a reduced meeting schedule, creation of interested citizen Working Groups and implementation of a program to incubate new neighborhood groups with funds from our Beautify SJ grant. SBSC was particularly challenging because there were no hold-overs from the prior Board. Many operational aspects were reimagined with two goals: year-round (instead of summer only) use of the community pool facility and increased communication with the 318 homeowner / HOA members. We were also able to increase revenues by ~30% which has helped to stabilize SBSC finances.
