REVISED MEMORANDUM

RECOMMENDATION

- a) Interview candidates for the interim appointment to Councilmember for District 10 on the San José City Council ("City Council").
- b) Consideration of appointment of candidate to a term as the Councilmember for District 10, to begin January 30, 2023 and end when a candidate has been duly elected in the next regularly scheduled election and the results of the election have been officially certified.

OUTCOME

The recommended action provides for the possible appointment of an applicant to Councilmember for City Council District 10, which will ensure the continued representation for Council District 10 until the next election.

BACKGROUND

The City of San José ("City") general election of 2022 saw the Councilmembers for Districts 8 and 10 elected to other offices leaving unanticipated vacancies for those Districts. On November 16, 2022, the Rules and Open Government Committee discussed and took action on a

memorandum submitted by Councilmembers Jimenez and Cohen regarding the anticipated vacancies for Districts 8 and 10. Staff was directed to prepare an informational memorandum outlining the process for filling Council vacancies, and to schedule a Special Meeting no later than December 18, 2022, for Council to decide the process for filling Council seats vacated by the recent election beginning January 1, 2023. That meeting was held on December 5, 2022, when the City Council directed the opening of a recruitment to fill the unanticipated vacancies in Districts 8 and 10 by interim appointment to fill the office until a candidate has been duly elected and the results of

the election have been officially certified. (City Charter Section 410)

On December 8, 2022, the City Clerk posted the application to the website. That same day, the City Clerk distributed the application to a contact list of individuals, organizations, and to the City Council. On December 14, 2022, the City's Twitter, NextDoor, and LinkedIn accounts posted the image included within this memorandum with a link to the applications. Additionally, an application advertisement was published on December 20, 2022, via Facebook and Instagram. The same image was also provided to Council Districts 8 and 10 for their direct use in recruitment.

The list of applicants was posted and updated each business day, along with a description of the process of selecting candidates for interview.

ANALYSIS
