A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE ACCEPTING THE 2022 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT IN THE AMOUNT OF \$367,516 AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE THE GRANT AGREEMENT AND ALL RELATED DOCUMENTS FOR THE GRANT AWARD RECEIVED FROM THE U.S. DEPARTMENT OF JUSTICE WITHOUT FURTHER CITY

**WHEREAS**, the City of San José ("City") has been participating in the Edward Byrne Memorial Justice Assistance Grant ("JAG") program since 2005; and

COUNCIL ACTION

**WHEREAS**, the City and the County of Santa Clara ("County") have been certified as disparate jurisdictions by the U.S. Department of Justice; and

**WHEREAS**, certified disparate jurisdictions are eligible to submit a joint application for funding and expected to come to an understanding regarding sharing of the grant funds; and

**WHEREAS,** the City, acting as the Fiscal Agent, applied for the 2022 JAG grant on August 5, 2022; and

**WHEREAS,** the County, acting as the sub-grantee, will receive \$94,582 of the \$367,516 grant award; and

**WHEREAS**, on August 4, 2022, the City developed a Memorandum of Understanding regarding the 2022 JAG program, which identifies the City as the Fiscal Agent for the grant and outlines the allocations for the City and the County; and

WHEREAS, the total grant funds will be disbursed to the City in 2022-2023, and the City

will fully expend the grant funding by September 30, 2025; and

WHEREAS, the proposed 2022 JAG Spending Plan, as described in the Council

memorandum, includes funds for crime prevention and education programs, air

purifying respirators, less lethal qualification training, allocation of funds to the County,

and grant administration; and

WHEREAS, the City desires to accept the 2022 JAG award and authorize the City

Manager to negotiate and execute all documents necessary to effectuate the grant in

order to further the San José Police Department's mission to promote public safety,

prevent, suppress, and investigate crimes, provide emergency and non-emergency

services, and adapt a multi-disciplinary approach to solving community problems;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN

JOSE THAT:

The 2022 Edward Byrne Memorial Justice Assistance Grant in the amount of \$367,516

is hereby accepted and the City Manager is hereby authorized to negotiate and execute

the Grant Agreement and all related documents for the grant award received from the

U.S. Department of Justice without further City Council action.
