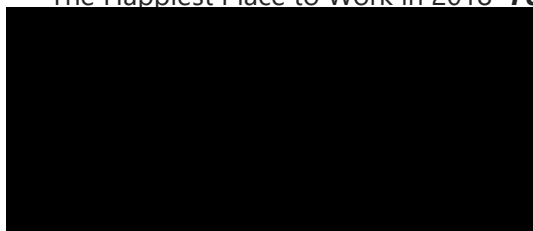

I am a stakeholder/resident for District 8.

I am disgusted at the City Council Meeting I went to (to speak) on Tuesday, January 24.

Here are my reasons for being disgusted...

1. I was told I could speak at 3pm

that was not true, you city council members just made it up as you went along. the agenda was in error.

I was informed by Mayor (public comment by him) that each candidate would go first and this took 30 minutes and so a member of the public had to wait 3 hours to do public comment, and then to make matters worse , a full hour for dinner took place so I had to wait over 4 hours to do my one minute public comment.

So, this should have been properly agendized. and figured out better by Mayor Mahan.

2. upon walking up to speak, I was treated bad by security. (now the security up stairs was excellent, but the security monitoring speakers is bad. I was told where to stand and rudely too.

I then did not see the TIMER on the visual screen. THEY DO NOT USE THE VISUAL TIMER but you board members can't see, so I could not see my time eroding and that is key to making presentation for one minute.

I did the best I could but was rudely cut off by the time monitor.

NOW MR. M A Y O R you got to speak to the timer person, she is rude and mean.

yes mean.

I ask you to get a new timer person or better help the current one to be kind and respectful for speakers (especially those who wait over 4.5 hours to speak)

what happened is she says **TIME**

AND that is bad way to treat San Jose residents.

what should have happened is San Jose, needs to do a complete review of this entire process of public comment

A. put an X on floor where people stand to wait as they are asked three at a time to wait to speak

B. Train the mean security lady to not be rude and to be kind, also the other security person is now trained to physically walk up to speaker (see video) and kind of physically (with close proximity) encroach on speakers if they go a bit over on time. This could be a safety issue in my view.

C. invest in a nice new method for public speakers... give them ONE MINUTE AND 15 SECONDS... as the time hits one MINUTE, then use a dull buzzer, as the time hits ONE MINUTE 15 SECONDS, then use an automatic other tone buzzer that will inform speaker time is up.

STOP THIS RUDE METHOD OF A PERSON SAYING

TIME

I have been told by many who spoke last night that they were treated rude, had a bad experience, and were cut off in mid sentence.

D. This is key point. ALWAYS ALWAYS ALWAYS, LET THE SPEAKER FINISH THE SENTENCE AND NOT BE RUDE WHEN THE COMMAND OF TIME IS DONE.

many are very upset at the way they were treated at the meeting last night. Many are very disgusted.

E. Mayor Mahan, you did well and were earnest in how you ran the meeting, but you got to be tough and enforce kindness. the current situation as to how public speakers are treated needs lots and lots of better oversight. the person who yells

out **TIME!!! needs a new system (A simple buzzer (automatic) and as stated above a dull sound for first minute than a sharper sound once a person gets to one minute 15 seconds). SO ALL FUTURE SAN JOSE CITY COUNCIL MEETINGS NEED TO CHANGE FROM ONE MINUTE SPEAKING TIME TO ONE MINUTE AND 15 SECONDS SPEAKING TIME FOR ALL SUCH CRUNCHED TIME MEETINGS.**
