BACKGROUND

The Administration has developed a tentative schedule of Study Session dates for February – April 2023 (Attachment A) to facilitate calendaring for the Mayor and Council. May 2023 Study Session dates were approved by the Rules and Open Government Committee on December 7, 2022 as part of the 2023-2024/2024-2025 Budget Calendar for review of the City budget.¹ No Study Sessions are anticipated for June 2023. As topics and agendas are set for the dates in the Attachment A, staff will bring dates and times forward to the Rules and Open Government Committee for approval.

Two Priority Setting Session meetings are set for February 14, 2023 and February 28, 2023 per the direction set in the January 18, 2023 Rules and Open Government Committee meeting to best inform the March Budget Message on City focus areas, outcomes, recommendations, and success metrics for the Fiscal Year 2023-2024 Budget Process.
