I am joining together with my community to request that you prioritize the following in the City Budget:

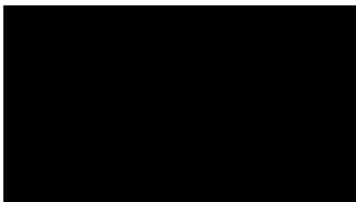
1. Prevent wage theft by resourcing the OEA and the County's Office of Labor Standards Enforcement to work together to provide outreach education and support to workers and businesses in sectors impacted by wage theft.
2. Develop a responsible construction ordinance to incentive new developers to work with contractors who treat workers with dignity and pay a fair wage.
3. Resource programs that enrich the next generation of San José residents.
4. Fill the 800+ job vacancies in the City and ensure City workers are fairly compensated and have opportunities for growth and development.

San Jose remains deeply economically divided — nearly half of all children live in families which make too little money to make ends meet. This inequality is bad for working families, bad for our neighborhoods, and bad for San José's regional economy. This continues the poverty mentality that permeates our racist structures and systems.

That's why I'm coming together with my San José community to demand that you create a budget that will consider the urgent and emerging needs of all residents across the City, regardless of where we live, what we do for a living, and how much money we make.

Council members

Your vote on the funding to give the Mobilehome Park designation to 13 Parks is simple. On 10-18-22 the vote to do this was passed unanimously. Matt Mahan's budget on page 24 simply codifies this and provides the funds.

Here are the Parks that were to be given the Mobilehome Park designation in this round: Oak Crest, Lamplighter, Quail Hollow, Chateau La Salle, Mill Pond 1 and 2, Caribees, Hometown, San Jose Mobile Home and RV Park, San Jose Trailer Park, La Buona Vita, Sunshadow, and Silver Creek Mobile Estates.

I believe little outreach is necessary since as the 10-18-22 memo stated: "this is work that our mobile home residents have both been aware of and actively fighting for since 2015."

For the record: my Park is not among the first 13. I have been waiting since 2015. Please get this done now and help protect the naturally occurring affordable housing stock in San Jose: the Mobilehome Parks.
