Hi, my name is Cindy Luong and I've been a long-time resident of East San Jose. We need to retain the original funds for the environment to make this place a safer place and add value to our community.

For far too long our communities' environmental issues have been put on the back burner and our representatives have faced constant pushback when bringing forward recommendations to make improvements to Lake Cunningham.

From where I live, I can ride VTA to the lake. But the water quality is so bad that if the lake floods into the park during these atmospheric river events, it leaves dangerous residue behind. (Let alone try to boat or swim on the lake.) This is one of the reasons the voters passed Measure T in 2018.

For far too long, our communities' environmental issues have been put on the back burner, and our representatives have faced constant pushback when bringing forward recommendations to make improvements to Lake Cunningham.

The Sierra Club Loma Prieta Chapter urges the Council to approve the memo from Councilmembers Candelas and Ortiz to maintain the City's commitment to improving water quality at Lake Cunningham through Measure T funding. Please do not take the \$3.2M in Measure T funds that was committed to improving water quality at a park located in a low-income community of color.

In 2018, the Sierra Club, with other organizations, engaged and mobilized our members and supporters to promote Measure T and provide information to voters. This \$650M infrastructure bond measure allocated \$50M for natural flood and water quality protection. With the City of San Jose, we celebrated the resulting acquisition of 937 acres of open space and farmland in North Coyote Valley for permanent conservation. The remaining \$3.2M in the "Environmental and Flood Protection Projects" funding category should be dedicated to water quality projects, as envisioned in Measure T.

We support the allocation of the remaining \$3.2M to improve the water quality at Lake Cunningham Park, which provides open space and recreation opportunities, as well as habitat restoration opportunities, to the less affluent community of East San Jose. Water quality in the lake has degraded so much that it has become toxic to fish and wildlife, and swimming and even boating have been prohibited for health and safety reasons. This is both an environmental embarrassment and an equity issue that San Jose should cure. The \$3.2 million in environmental funding will help begin the path to improved water quality.

Lake Cunningham is not only a recreational resource, it is a remnant of San Jose's historical geomorphology and heritage. Lake Cunningham was once known as Laguna Socayre, a wetland where creeks merged to support willow thickets and a rich fauna of fish, birds and wildlife. A project to restore water quality in Lake Cunningham could include constructed

wetlands to remove contaminants from the water and provide valuable ecosystem benefits to the region, including flood protection, habitat, and climate resilience.

We urge the Council to approve the memo from Councilmembers Candelas and Ortiz and maintain the City's commitment to improving water quality at Lake Cunningham through Measure T funding.

The undersigned organizations urge the Council to approve the memo from Councilmembers Candelas and Ortiz and maintain the City's commitment to improving water quality at Lake Cunningham through Measure T funding. Please do not take away the \$3.2M in Measure T funds that was previously committed to improving water quality at a park located in a low-income community of color.

Background

In 2018, San Jose voters overwhelmingly approved Measure T, a \$650M infrastructure bond measure. In a groundbreaking move, \$50M of that funding was designated by the City Council for natural flood and water quality protection, focused primarily on Coyote Valley. The 2019 acquisition of 937 acres of open space and farmland in North Coyote Valley for permanent conservation used less than the full \$50M, leaving \$3.2M unused in the "Environmental and Flood Protection Projects" funding category. In 2021, the Council unanimously voted to keep that \$3.2M dedicated to water quality projects, such as improving the water quality of Lake

Cunningham – a purpose that is aligned with Measure T’s language concerning funds for natural flood and water quality protection.

This funding was always intended to be used for environmental protection. The vast majority of Measure T funding has already been used for other infrastructure projects. Voters were told in 2018 that \$50M of the funding would go towards natural flood and water quality protection, and the Council reaffirmed that commitment in 2021. The City should not abandon that commitment to the voters by taking this \$3.2M away from environmental protection and using it for other purposes.

Importance of Lake Cunningham

For generations, Lake Cunningham served as one of the primary open space recreation areas for the East Side. Families who could not afford weekends at Lake Tahoe had their own lake, in their own neighborhood, where they could swim, boat, and hold weddings and quinceañeras. But for decades, water quality in Lake Cunningham has been degrading to the point where now, swimming and even boating have been prohibited for health and safety reasons. This is both an environmental disaster and a major inequity inflicted upon a low-income community of color. The \$3.2 million in environmental funding will help begin the path to improved water quality.

Furthermore, restoring the water quality in Lake Cunningham is an important natural resource issue. The area surrounding Lake Cunningham was once a freshwater marsh known as Laguna Socayre. Streams coming down from the hills spread out in the several thousand acres of bottomlands that lay at the foot of the alluvial fans, and formed wetland complexes where discontinuous streams interspersed with willow thickets. Lake Cunningham is not only a recreational resource; it is a significant remnant of San Jose’s historical wetlands, and as such could be providing valuable ecosystem benefits to the region, including flood protection, habitat, and climate resilience.

We urge the Council not to walk back the commitment made in June 2021 for the use of the \$3.2M in funding for water quality improvement. Please reaffirm the Council commitment to the voters to use this funding for prevention of water quality contamination.
