Out of 3000 students, I was one of 15 to be recommended to help lead the Student Equity Council and be involved in the Multi Tier Support System. This is because my teachers saw my interest in class for promoting racial equity and inclusion. In our biweekly meetings, I learn how I can help foster racial diversity through promoting more cultural festivals, calling people out on racial slurs and cultural appropriation, and hearing peoples stories. In the council, I've been working on a cultural parade which entails food, performances, and activities of Latinx and Afro-American culture in our school community. This is important for our school community to realize that people of any race or color are accepted and welcomed. We hope to achieve fair representation of marginalized individuals in our student council, activities, and clubs.

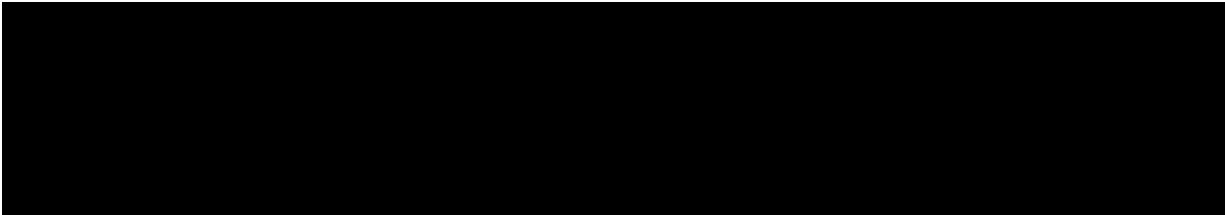
