The objectives and aligned core capabilities were selected by the Exercise Planning Team after an extensive review of lessons learned, after-actions reports, and newly develop local emergency management products.

Participant Roles and Responsibilities

The term *participant* encompasses many groups of people, not just those playing in the exercise. Groups of participants involved in the exercise, and their respective roles and responsibilities, are as follows:

- **Players** respond to the situation presented based on expert knowledge of response procedures, current plans and procedures, and insights derived from training.
- **Facilitators** provide situation updates and moderate discussions. They also provide additional information or resolve questions, as required.
- **Presenters** provide information about topics in emergency management.
- **Observers** primarily view the exercise. They may ask relevant questions.

Exercise Structure

Introduction

The Mayor will provide welcoming remarks and turn the program over to the City Manager.

The City Manager will provide keynote opening and frame the day and the role of the City Council.

Module 1

Complete a review of past EOC activations, with emphasis on COVID-19 and the recent 2022-2023 winter storms and atmospheric rivers. Review elected officials' role during an emergency and the purpose of a Disaster District Office (DDO).

This module will focus on Objective 1.

Module 2

Introduce 7.2M earthquake scenario and the roles of the EOC and the Continuity of Operations Plan (COOP). Also review the role of the different EOC and Department Operations Centers (DOC) staff positions. Various EOC and DOC representatives will be asked to contribute to the discussion. There will also be discussion about some of the City's current emergency planning efforts. Participants can expect to respond to questions that develop organically during this module.

This module will focus on Objectives 2 and 3.

Exercise Guidelines

This is intended to be a safe, open environment. The problems and challenges are real and there is no "textbook" solution. The following exercise ground rules have been developed to ensure that the goals and objectives are met in a reasonable amount of time and the tabletop exercise runs smoothly:

- Keep the exercise's objectives in mind throughout the exercise;
- Treat the scenario incidents as real events and play your appropriate role;
- Participate openly and focus discussions on appropriate topics asking questions, sharing thoughts, and offering forward-looking, problem-solving suggestions, which are strongly encouraged, as these will enhance the exercise experience;
- The Mayor and each Councilmember can **interrupt two times** during the study session to ask a question or make a comment. Once the Mayor and all Councilmembers have used their two interrupts, everyone will get two more interrupts for the duration of the study session;
- Keep your questions and comments focused and consider the time constraints; and
- Respect the observations, opinions, and perspectives of others, as the discussions will explore a variety of policies, decisions, actions, and key relevant issues from different sources.

Exercise Assumptions and Artificialities

In any exercise, a number of assumptions and artificialities may be necessary to complete play in the time allotted. During this exercise, the following apply:

- The scenario is plausible, and events occur as they are presented;
- There is no "hidden agenda" or any trick questions; and
- All players receive information at the same time.

Exercise Control

The facilitated tabletop exercise uses a scenario-based approach to create the decision-making environment for you, as a participant, to act in your role. This is a no-fault exercise that focuses on expanding the knowledge base among the Mayor and City Councilmembers and help set expectations of how they receive information from the EOC during an incident, and ideas of what to do to support their community.

The facilitators are responsible for keeping discussions on track with exercise objectives and ensuring that all issues are explored (time permitting). In general, the facilitators will keep side conversations to a minimum and keep discussions on track and within established time limits.



- Facilitation of the EOC, ensuring communication and coordination among the teams in the center and in the field. (Kip Harkness)


Council Discussion (Lee Wilcox)
