Dear Mayor Mahan and Councilmembers:

I am writing on behalf of Community Health Partnership, Inc. (CHP), an association of ten community health center organizations that provide primary care, behavioral health, and other related services to residents of San Jose. The vast majority of patients served by our members are Medi-Cal eligible and live below 200% of the federal poverty level, which is less than \$55K per year for a family of four. Our members serve San Jose communities hardest hit by the COVID-19 pandemic, and that is why several of CHP's Board of Directors (who are the CEOs of the community health centers) served for six months on the City's COVID-19 Recovery Task Force. Additionally, I had the honor to serve as Chair of the Community Health and Wellness Subcommittee and CHP staff member, Patty Diaz, served as co-chair of the Community Engagement Subcommittee.

In November of 2022, the San Jose City Council approved the recommendations of the City's COVID-19 Recover Task Force. These recommendations focused on:

- Community Health and Wellness
- Community Engagement
- Childcare, Early Care and Education, and Youth Development
- Housing
- Just Recovery for Airport, Hotel, and Arts Workers
- Supporting Small Business
- Workers' Health, Safety, and Rights

In light of the work done by the Task Force, and the unanimous adoption of its recommendations by the City Council, we were disappointed that there was no specific reference in the Mayor's Budget Message to allocate funding to implement those recommendations to work towards meaningful COVID-19 recovery for impacted communities. Therefore, we ask that subsequent FY24 budget documents reflect a financial commitment to the recommendations of the Task Force. As the Chairs and members of the Community Health and Wellness and Community Engagement Subcommittees, we offer our assistance to provide input for a budget proposal.

CHP would also like to express concern for the Mayor's proposal to divert Measure E funds, one of the only significant sources of funding for preventing homelessness and creating interim and permanent housing, to pay for a locked psychiatric facility. Measure E funds should be allocated, as intended, for the prevention of homelessness through cash assistance, creating interim shelter solutions, and investing in long-term permanent affordable housing. And, while we acknowledge the Mayor's mention of supporting racial equity, we strongly believe that implementing the recommendations of the COVID-19 Recovery Task Force would lead to improvements in quality of life, financial recovery, and community wellbeing to those families that would otherwise be left behind.

The recommendations of the City's COVID-19 Recovery Task Force must not be shelved. It deserves a budget allocation for FY24. The City can advance equity in recovery from the pandemic by moving forward on key priorities of the Recovery Task Force to address the continuing needs of the communities hit hardest by the pandemic, especially families and children. To this end, the City should budget an additional \$2 million to further high priority and high impact recommendations.

As an association of ten community health center organizations, our mission has focused on health and community engagement-related priorities, as reflected by our specific work on the Task Force. However, we strongly believe that the work of the full Task Force warrants a continued commitment and financial investment by the City of San Jose to achieve recovery and health/racial equity for all residents of San Jose.

Thank you for your consideration and please know that this organization stands ready to assist the Mayor, Council, and City Staff to ensure that meaningful recovery begins now.

With that in mind, we appreciate the Mayor's intention in his March Budget Message to explore additional funding to support our arts community and other initiatives to improve the vibrancy and quality of life in San José (p. 25). The arts, entertainment, and hospitality industries were the first to be decimated by the pandemic and will be the last to fully recover — if they ever fully recover.

In order to achieve the Mayor's goals and create a more sustainable arts and cultural community in San José, we call on you to take the following actions:

- Direct the City Manager, beginning in Fiscal Year 2023-2024, to reapportion the current General Fund allocation from the City's Transient Occupancy Tax (TOT) equally across the remainder recipients of TOT funding: the Office of Cultural Affairs — including Cultural Grants Programs the Convention and Visitors Bureau (Team San José), and Convention and Cultural Facilities;
- 2. Direct the City Manager to work with local stakeholders including SJAA to identify budget policy strategies to guide the long-term investment of the TOT to better serve the arts, culture, entertainment, and hospitality industries which play a large role in generating the TOT and return to Council within the next fiscal year with strategies for consideration and implementation;
- Direct staff from the Office of Economic Development and Cultural Affairs (OEDCA) to develop a
 framework for a Private Percent for Art policy, common in other Bay Area cities, which has been
 on the City Council's priority list for more than three years; and
- 4. Direct staff to explore a pilot program to employ Artists in Residence within City departments to apply a creative, problem-solving lens to some of the City's intractable challenges and help build deeper civic engagement in the policy making process.

We hope you will support these priorities for preserving, protecting, and promoting our creative community, which collectively generates hundreds of millions of dollars of economic impact for our city, creates thousands of jobs, inspires us to engage, and improves the quality of life for all our residents.

To quote the Mayor in a recent San José Spotlight article, "we can move the needle on these issues if we focus our attention, our **creativity** and our resources on them." We couldn't agree more, and we look forward to bringing more creativity to City Hall.

REAL Coalition Letter Re: Item 3.5 Approval of the Fiscal Year 2023-2024 Mayor's March Budget Message

Dear Mayor Mahan and City Council:

This letter was prepared by members of the Race Equity Action Leadership (REAL) Coalition.

Background

The REAL Coalition sent no fewer than three letters to the Mayor and City Council regarding the transition committee process and reports, expressing disappointment in the Mayor's Transition Committee process and the failure of the committees to address important strategies, especially many that would further racial justice and equity. In response to the strong voice of community-based organizations and allies, a number of our priorities appear in the Mayor's March Budget Message.

While we acknowledge this movement in response to our requests, we write to express concern relating to a number of the Mayor's proposals, ask that additional important priorities be added, and more detail be included in some of the priorities that do appear in the Budget Message.

• The proposal to raid Measure E funds—which is one of the only significant sources of funding for preventing homelessness and creating interim and permanent housing—to pay for a locked psychiatric facility is outrageous. This plan would drain the fund of every last dollar of Measure E funding for 10 years. Measure E funds should be allocated in the balanced way that it currently is: preventing homelessness with cash assistance, creating interim shelter solutions, and investing in the long-term solution of permanent

affordable housing.

- Likewise, we strongly oppose the criminalization of homelessness by creating no-encampment zones. We have a shortage of extremely affordable housing and expending our resources on punitive solutions will not solve that problem. We should not focus our attention on knee-jerk, band-aid solutions that criminalize poverty and hide the problem of homelessness, but instead should keep our eyes on the ball.
- Although the Mayor's Message speaks to racial equity at the end of the
 message, we need to put our money where our mouth is. We should
 advance racial equity work in the City of San José by ensuring that City
 positions dedicated to this work are filled. In light of failure to hire key
 positions in Parks, Recreation, and Neighborhood Services; Planning,
 Building, and Code Enforcement; and Transportation, those positions
 should be converted to permanent Program Manager positions.
- Although the Mayor's Message acknowledges the work of the Recovery Task Force, it does not call on a budget allocation for FY24. The work of the Task Force shouldn't sit on a shelf. The City should advance equity in recovery from the pandemic by evaluating and moving forward key priorities of the Recovery Task Force, in order to address the continuing needs of the communities hit hardest by the pandemic, especially families and children, in partnership with the County and other partners. The City should budget an additional \$2 million to further high priority and high impact recommendations. As staff the Council Committees assess which priorities to move forward, the Task Force should be consulted as appropriate.
- For the past several years, the REAL Coalition has been advocating for the City to improve its approach to civic engagement. We have seen some promising examples of deeper community engagement in how the City handled the Recovery Task Force, the Youth Empowerment Alliance strategic planning process, and the Reimagining Public Safety Community Advisory Committee (RiPS) process. Council should earmark at least \$500,000 for developing an enterprise-wide civic engagement strategy, including a civic engagement policy and framework, training for staff, high

level coordination, and work with a diverse group of community members to develop this strategy. Although the Office of Racial Equity is doing great work in creating San José 4 All in co-creation with the community, this type of approach should be embedded across the City, in the context of a Citywide policy. And while we acknowledge the Mayor's instruction to the Administration to include funding for continuing the promotoras pilot, we request specificity. The City should continue the promotoras pilot started last year with an additional investment of \$500,000 and work with philanthropic and nonprofit partners to seek philanthropic and other partner investments in the model.

- As described in the Mayor's message, we ask Council to fund and move forward with a planning process to implement a community-based interpersonal violence prevention and response pilot, and work with Next Door Solutions to Domestic Violence and the Coalition to design a plan. This will further public safety reform by moving forward key and achievable priorities identified in the Reimaging Public Safety (RiPS) report. We ask for a specific allocation of \$400,000 to ensure a robust communitycentric approach.
- Lastly, Council should double down on the City's investment in prevention and intervention of violence by adding \$5 million to the San José Bringing Everyone's Strengths Together City-Wide Appropriation. Whereas the Mayor acknowledges the importance of prevention and intervention in his message, the budget should express this stated value.

We are interested in the references in the Message to divert calls from 911 and other possibly innovative ways to move away from unnecessary policing and carceral approaches. We call on the City to involve the community at a deep level in these conversations. The REAL Coalition stands ready to participate in these dialogues and to support the City in bringing the voices of community members with relevant lived experiences to the table. We appreciate the Council offices that engaged in dialogues with Coalition members during this process.



Honorable Mayor and City Council,

My name is Carman, and I am an Arts Advocate, Arts Administrator, and lifelong resident of San José. I am writing to you today regarding Item 3.5 on your agenda for Tuesday, March, 21, Approval of the Fiscal Year 2023-2024 Mayor's March Budget Message.

As an Arts Advocate, I believe that arts and culture are essential to the economic, social, and civic wellbeing of our city. I appreciate the Mayor's intention in his March Budget Message to explore additional funding to support our arts community and other initiatives to improve the vibrancy and quality of life in San José (p. 25).

In order to achieve the Mayor's goals and create a more sustainable arts and cultural community in San José, I call on you to take the following actions:

- 1. Direct the City Manager, beginning in Fiscal Year 2023-2024, to reapportion the current General Fund allocation from the City's Transient Occupancy Tax (TOT) equally across the remainder recipients of TOT funding: the Office of Cultural Affairs — including Cultural Grants Programs — the Convention and Visitors Bureau (Team San José), and Convention and Cultural Facilities;
- 2. Direct the City Manager to work with local stakeholders, including SJAA, to identify budget policy strategies to guide the long-term investment of the TOT to better serve the arts, culture, entertainment, and hospitality industries — which play a large role in generating the TOT — and return to Council within the next fiscal year with strategies for consideration and implementation;
- 3. Direct staff from the Office of Economic Development and Cultural Affairs to develop a framework for a Private Percent for Art policy, common in other Bay Area cities, which has been on the City

Council's priority list for more than three years; and

4. Direct staff to explore a pilot program to employ Artists in Residence within City departments to apply a creative, problem-solving lens to some of the City's intractable challenges and help build deeper civic engagement in the policy-making process.

I am proud to stand with San José Arts Advocates to support these priorities for preserving, protecting, and promoting our creative community, which collectively generates hundreds of millions of dollars of economic impact for our city, creates thousands of jobs, inspires us to engage, and improves the quality of life for all of our residents.
