The Mayor's message stated we need to "invest in the greatest opportunities in specific districts, including unique and important cultural facilities such as the Vietnamese Heritage Garden." I couldn't agree more.

The Vietnamese Heritage Garden is envisioned as a place where the culture and history of Vietnam are represented in art and architecture. It was promised almost three decades ago to the residents of San José as a 4-acre grand destination for all San Joséans. All structures and gardens on the site will replicate or interpret important Vietnamese historical buildings and artifacts.

The master plan calls for two large buildings consisting of a 7,000sqft cultural museum and a 4,500sqft exhibition hall which was to be used for community meetings, weddings, and more.

Currently my office is working with staff to deliver on the "Thank You America" Monument which is to be finished sometime next year as the first main improvement to the vacant parkland in quite some time.

Our Vietnamese population in San Jose has steadily increased over the past 48 years and has been a great contributor to our city economically and culturally, especially in the arts, food, and technological innovation. It is time to deliver on the promises made to our San Jose residents: we must update the original Vietnamese Heritage Garden master plan for improved community use as a near-term goal and develop a pathway to fund its construction and use as a future goal.
