SUBJECT: APPROVAL OF TOWER LIGHTING FOR THE WESTERN PROVINCE COUNCIL OF KAPPA ALPHA PSI FRATERNITY REGIONAL CONFERENCE ON APRIL 12-16, 2023, SPONSORED BY THE MAYOR'S OFFICE AS A CITY COUNCIL SPONSORED SPECIAL EVENT

RECOMMENDATION:

- 1. Approve the 76th Western Province Council of Kappa Alpha Psi Fraternity Regional Conference Tower Lighting on April 12-16, 2023.
- 2. Place the item on Tuesday, April 11, 2023, Council Agenda for action.

BACKGROUND:

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds in Special Events Accounts.

The 76th Western Province Council of Kappa Alpha Psi Fraternity Regional Conference will be held on April 12-16, 2023, in San José. The Tower will be lit red from April 12-16, 2023, in honor of the 76th Western Province Council of Kappa Alpha Psi Fraternity Regional Conference returning to San José after nearly 30 years and will be sponsored by Mayor Mahan.

The Kappa Alpha Psi Fraternity, Inc. (KAΨ) is a historically African American fraternity. Since the fraternity's founding on January 5, 1911, at Indiana University Bloomington, the fraternity has never excluded membership on the basis of color, creed or national origin. Kappa Alpha Psi is the 2nd oldest existing collegiate historically Black Greek Letter Fraternity and the 1st intercollegiate Fraternity incorporated as a national body. Their motto is Achievement in Every Field of Human Endeavor. Through its worldwide prominence, Kappa Alpha Psi has had a global impact on events which affect local communities, as well as places around the globe. Local chapters of Kappa Alpha Psi participate in community outreach activities to feed the

homeless, provide scholarships to young people matriculating to college, serve as mentors to young men, participate in blood drives and serve as hosts of seminars for public health awareness to name a few. The Kappa Alpha Psi Fraternity, Inc. San Jose Alumni Chapter was chartered on September 25, 1970, and the Delta Rho Chapter at San Jose State University was chartered on June 16, 1956. Both Chapters are hosting the 76th Western Province Council Regional Conference in San José. The Tower lighting honors the Kappa Alpha Psi community residing in the San José metropolitan area.

ANALYSIS:

City Council Policy 7-14, City Hall Event Lighting Policy, Sections B.1 and C.1 allows Tower lighting in conjunction with proclamations for official actions or ceremonial items as approved by City Council. It also allows for extended lighting beyond one cycle between sundown and sunrise.

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. Approval of this memorandum will enable Council Mayor's Office, City departments, and the Office of the City Clerk to proceed with the lighting.
