RECOMMENDATION

- 1. Retroactively Approve the Persian New Year, Nevruz event that was scheduled on Saturday, March 18, 2023, as a City Council-sponsored Special Event and approve the expenditure of funds.
- 2. Place the item on April 11, 2023, Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council-sponsored Special Events and the proposed use of any funds.

The Persian New Year, Nevruz celebrated by many cultures was scheduled on Saturday, March 18, 2023. Council office D10 partnered with the Azerbaijan House to help celebrate the first day of Spring also known as Nevruz. Information booth distributed City and D10 literature during the sign-in at the event. Councilmember Batra sponsored the event, and it was open to all public and residents of D10.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmembers Batra, Foley, and Jimenez will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
