A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING THE CITY MANAGER TO EXTEND OTHER TRANSACTION AGREEMENT AWARD NUMBER 70T02021T6114N108 WITH TRANSPORTATION SECURITY ADMINISTRATION TO REIMBURSE THE MINETA SAN JOSE INTERNATIONAL AIRPORT (AIRPORT) FOR ELIGIBLE COSTS OF APPROXIMATELY \$900,000 FOR DEPLOYMENT OF LAW **ENFORCEMENT OFFICERS** EACH AΤ PASSENGER-SCREENING LOCATION AT THE AIRPORT **FROM JANUARY 1, 2023 TO DECEMBER 31, 2025**

WHEREAS, the City of San José ("City") owns and operates the Mineta San José International Airport ("Airport"); and

WHEREAS, the Transportation Security Administration ("TSA") and federal law requires that the Airport maintain a law enforcement officer ("LEO") presence at security passenger-screening locations adequate to ensure passenger safety and national security; and

WHEREAS, contingent upon TSA's approval of Airport's application, and subject to availability, TSA may award funds to partially reimburse the Airport for eligible costs incurred associated with the LEO's; and

WHEREAS, funds awarded to Airport by the TSA for LEOs shall be subject to the negotiated terms and conditions of an Other Transaction Agreement ("OTA") with the TSA; and

WHEREAS, in November 2020, City Council authorized City Manager to execute an OTA with TSA to fund eligible costs for deployment of LEO's at each passenger-screening location at the Airport for a two-year period from January 1, 2020 through

December 31, 2022, with allowances for extensions up to a five-year period, through

December 31, 2025; and

WHEREAS, City desires to authorize the City Manager to extend the OTA for the period

retroactive from January 1, 2023 to December 31, 2025 to reimburse the Airport for

eligible costs of approximately \$900,000;

The City Manager is hereby authorized to extend the LEO OTA for the period retroactive
