BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds. The Fuerza y Unión Grammercy Egg Hunt connected children and families in the

District 5 neighborhood of Grammercy to a resource fair and fun activities. The event was held on April 8th, 2023, at Children of the Rainbow Park. The Clean California Community Day Highway Cleanup was a cross jurisdictional initiative that invited community members to earn service hours and help beautify San José. The event was held on April 15^h, 2023 at the freeway entrance of I-680/Capitol Expressway. The Poco Way Día del Niño Event connected children and families in the District 5 neighborhood of Poco Way to a resource fair and fun activities, honoring Day of the Child. The event was held on April 20th, 2023 at the Poco Way Apartments. The Great American Litter Pickup invited community members to earn service hours, meet neighbors, and help beautify San José streets. The event was held on April 22nd, 2023, at different neighborhoods in District 5. The Fuerza y Union Grammercy Día del Niño Event connected children and families in the District 5 neighborhood of Grammercy to a resource fair and fun activities, honoring Day of the Child. The event was held on April 29th, 2023, at the Children of the Rainbow Park. The Mount Pleasant Neighborhood Association One CommUNITY event invited District 5 families to a cultural event, showcasing the various ethnicities of San José, as well as connecting attendees to community resources. The event was held on April 29th, 2023, at the Robert Sanders Elementary School. The Mexican Heritage Plaza Poetry event will pay tribute to East San José's creative spirit, and invite residents to enjoy Poetry performances, as well as connect attendees to community resources. The event will be held at the Mexican Heritage Plaza, on May 6th. The Indian Health Center of Santa Clara Valley Center American Indian Graduation event will pay tribute to San José's Native American population and invite residents to celebrate graduates from the community, as well as connect attendees to community resources. The event will be held at the City Hall, on May 10th.

The 8 events were/will be free, open to the public, and sponsored by Councilmember Peter Ortiz.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Peter Ortiz will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 5, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
