Adopt a resolution approving the terms of a collective bargaining agreement between the City and the San José Police Officers' Association (SJPOA) for the term of July 1, 2021 through June 30, 2022, and authorizing the City Manager to execute the agreement with those terms.

Mayor Sam Liccardo highlighted key points and hopeful steps brought forward in the agreement. Director of Employee Relations/Human Resources, Jennifer Schembri and Assistant City Manager Jennifer Maguire responded to questions regarding civilianizing positions.

Direct the City Administration and the Office of the City Attorney to take the following actions related to the further exploration of the issuance of Pension Obligation Bonds as a funding option for the City's unfunded accrued liabilities in the Federated City Employees' Retirement System and the Police and Fire Department Retirement Plan: (a) Proceed with planning and preparation of bond documents and court validation documents necessary for the issuance of Pension Obligation Bonds ("POBs") and return to City Council on June 29, 2021 with the necessary actions to proceed with court validation;

- (b) Prepare a Pension Obligation Funding Policy for City Council review and approval;

<u>Action</u>: On a call for the question, actions Related to Continued Exploration of Pension Obligation Funding Strategies were accepted, including the May 10, 2021 memorandum from Councilmember Matt Mahan requesting more detailed analysis:

- 1. In order to thoroughly understand the risks involved with issuing pension obligation bonds (POBs), direct the City Manager to highlight, in Fall 2021, a detailed POB risk and benefit analysis that includes a long-term, year-by-year projection of the potential impacts on the unfunded actuarial liability (UAL) and General Fund contributions toward the UAL, of both issuing and not issuing substantial POBs under the following market scenarios:
- a. Investment expectations are met (i.e. the 6.625% discount rate),
- b. A severe market downturn akin to 2001/2002 or 2007/2008,
- c. Prolonged underperformance (achieving 4 to 5% returns every year),
- d. And more generally, a best case and worst case scenario. (11-0.)

Accept the staff report on public purpose bonds issued by a joint powers authority (JPA) for moderate-income housing, and direct the Administration not to move forward with releasing a term sheet in order to pursue membership in one or more JPAs for moderate-income housing at this time.

Councilmember Matt Mahan directed questions to public speaker John Penkauer.

<u>Motion</u>: Councilmember David Cohen moved approval of the memorandum he coauthored with Councilmember Matt Mahan dated May 7, 2021.

Mayor Sam Liccardo posed questions to Director of Housing Jacky Morales-Ferrand regarding staff capacity. She indicated that independent consultants have also been critical, and there's no such thing as a pilot for this. Division Manager, Housing, Kristen Clements offered additional information.

<u>Substitute Motion</u>: Vice Mayor Chappie Jones expressed concerns regarding "the resource and risk scenario" and offered a substitute motion to accept the staff report including only #3 from the May 7 memorandum to include a list of alternative methods that city staff might pursue to build or otherwise secure missing middle housing in the near future. Councilmember Maya Esparza seconded the motion.

Action: On a call for the question, the substitute motion passed, with acceptance of the staff report on public purpose bonds issued by a joint powers authority (JPA) for moderate-income housing was accepted, including the joint memorandum from Vice Mayor Chappie Jones and Councilmember Maya Esparza, dated May 7, 2021, directing staff to:

• Pursue Alternative #2: Direct staff to work with the Bay Area Housing Finance Authority to create a Bay Area JPA to issue this type of bond. • Include updates on the progress of this effort at each Housing Crisis Workplan Update.

Also including Item #3 from the joint memorandum from Councilmembers Mahan and Cohen, dated May 7, 2020, to "Include a list of alternative methods that city staff might pursue to build or otherwise secure missing middle housing in the near future".

Hector Estrada, Deputy Fire Chief/Fire Marshal offered a presentation. SJPD Captain Jason Ta continued with the enforcement strategy and work plan items. Staff and Public Information Manager, SJFD, Erica Ray, responded to questions.

Public Comments: Blair Beekman provided comments.

<u>Action</u>: Upon motion by Councilmember Sergio Jimenez, seconded by Councilmember Raul Peralez and carried unanimously, the status report on implementation of the Fireworks Ordinance Workplan Pre-Fourth of July 2021 was accepted. (11-0.)

## 4.2 21-1020 Amendment to Title 10 (Social Host Ordinance) and to 2020-2021 Schedule of Fees and Charges for Illegal Fireworks.

- (a) Approve an ordinance amending Chapter 10.17 of Title 10 of the City of San José Municipal Code to:
- (1) Add Sections 10.17.060 and 10.17.070 to define Social Host and Strictly Liable;
- (2) Amend Section 10.17.030 to define private and public property;
- (3) Amend Section 10.17.100 to impose strict liability on social hosts for fireworks violations at their property and/or gatherings;
- (4) Add Section 10.17.130 to provide a billing mechanism for charging responsible parties for emergency response costs associated with fireworks violations; and
- (5) Add Section 10.17.140 to include an administrative appeal procedure for recipients to dispute the imposition or amount of a response charge.
- (b) Adopt a resolution amending the 2020-2021 Schedule of Fees and Charges (Resolution No. 72737, as amended) to establish response charges for emergency responses related to fireworks violations. CEQA: Not a Project, File No. PP17-008, General Procedure and Policy Making resulting in no changes to the physical environment. (Fire/Police/City Manager)

Hector Estrada, Deputy Fire Chief/Fire Marshal offered a presentation.

Public Comments: Blair Beekman provided comments.

Councilmember Maya Esparza moved her memorandum dated May 10, 2021 with the addition that all offices be included in the media outreach. Councilmember Dev Davis seconded the motion.

<u>Action</u>: On a call for the question, (a) **Ordinance No. 30569** amending Chapter 10.17 of Title 10 of the City of San José Municipal Code was passed for publication; and (b) **Resolution No. 79992** amending the 2020-2021 Schedule of Fees and Charges (Resolution No. 72737, as amended) was adopted, with the addition of Councilmember Maya Esparza's May 10, 2021 memorandum to:

1. Accept Staff recommendations regarding the adoption of the Social Host Ordinance and amended 2020-2021 Schedule of Fees and Charges to establish charges for emergency responses related to fireworks violations.

6.1 21-1021 Amendment to San José Clean Energy 2021 Service and Rate Changes.

Adopt a resolution:

- (a) Amending San José Clean Energy's (SJCE) GreenSource default product beginning May 15, 2021 by increasing its renewable energy content to 55% and increasing its rates to 8% above Pacific Gas and Electric Company's (PG&E) generation rates after accounting for the Franchise Fee Surcharge and the Power Charge Indifference Adjustment, provided that SJCE's 100% renewable energy TotalGreen product will continue to be 0.5-1 cent per kWh higher than GreenSource;
- (b) Establishing a third product called GreenValue, with rates set at parity to PG&E generation rates after accounting for the Franchise Fee Surcharge and the Power Charge Indifference Adjustment; and (c) Establishing the SJ Cares program for CARE (California Alternate Rates for Electricity) and FERA (Family Electric Rate Assistance) customers, for whom GreenSource generation service will be set at parity to PG&E generation rates after accounting for the Franchise Fee Surcharge and the Power Charge Indifference Adjustment. CEQA: Not a Project, File No. PP17-008, General Procedure and Policy Making resulting in no changes to the physical environment. (Community Energy)

Director, Community Energy Department, Lori Mitchell and. Zach Struyk Assistant Director provided a presentation and responded to questions.

## 8.2 21-1048 Approval of Supported Isolation and Quarantine Funding Agreement with Santa Clara County.

- (a) Authorize the City Manager to negotiate and execute a Cost Sharing Agreement with the County of Santa Clara for up to \$10,000,000 to provide supported isolation and quarantine services to City residents toward containing and mitigating community spread of COVID-19 in the City of San José (Isolation and Quarantine Support Program) for a term retroactive from December 31, 2020 through June 30, 2021; subject to the appropriation of funds; and
- (b) Accept \$640,000 from the County to provide meals to non-San José residents who are staying in motels as part of the County's Isolation and Quarantine Support Program.
