SUBJECT: APPROVAL OF THE DISTRICT 4 BERRYESSA ART FESTIVAL AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

1. Approve the District 4 Berryessa Art Festival that will be held on Saturday, May 13, 2023 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the Tuesday, May 9, 2023 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 4 Berryessa Art Festival will be held on Saturday, May 13, 2023 from 10:00 a.m. to 4:00 p.m. at 3050 Berryessa Road. The purpose of this event is for San Jose residents to gather, socialize and create fun memories with a day full of shopping, drinking, and eating. There will be artists and artisans selling their wares, beverages, a variety of food trucks, and live entertainment from local musicians and students. This event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember David Cohen will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
