**SUBJECT: REPORT ON BIDS AND AWARD OF CONTRACT FOR THE 2023 LOCAL STREETS REMOVE AND REPLACE PAVEMENT PROJECT**

## **RECOMMENDATION**

- a) Report on bids and approve award of contract for the 2023 Local Streets Remove and Replace Pavement Project, to the low bidder, O'Grady Paving, Inc., in the amount of \$3,833,200 and;
- b) Approve a 10% contingency in the amount of \$383,000.

## **SUMMARY AND OUTCOME**

Approval of this contract provides required asphalt concrete pavement repairs along the 51 miles of Local and Neighborhood Streets Network to be sealed in the 2023 construction season.

Approval of the 10% contingency provides funding for any unanticipated work necessary for the proper completion or construction of the project.

## **BACKGROUND**

The Department of Transportation (DOT) will maintain approximately 161 miles of streets on the Local and Neighborhood Streets Network in the 2023 construction season: 110 miles will be resurfaced due to their poor to failed condition and 51 miles will be sealed.

Pavement maintenance is typically performed in two separate phases: preparation and a final surface application. The preparation phase consists of the installation or upgrade of Americans with Disabilities Act curb ramps and the removal and replacement of failed asphalt pavement. The Americans with Disabilities Act work is conducted in advance using minor contracts to provide more opportunities for local and small businesses. Streets to be sealed will also require

the removal and replacement of any structurally failed areas of pavement prior to the final surface application phase. The final surface application phase is also known as sealing application, which provides of a thin layer of asphalt emulsion blended with rock approximately 3/8 an inch in depth to the pavement.

The City's Local and Neighborhood Streets Network is organized into 135 geographically contiguous Pavement Maintenance Zones. The Pavement Maintenance Zones were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic spread of pavement maintenance across the City.

DOT utilizes a Pavement Management System to collect and store roadway condition data that is used to generate a candidate list of streets to be considered for the annual pavement maintenance program. The candidate list is then thoroughly analyzed by staff using the following criteria to create the final list of streets:

- Funding availability and funding use restrictions
- Streets on the Local Street Network
- Streets not affected by current or future street related projects
- Maintenance history and prescribed treatment schedules
- Streets associated with planned safety, bikeway, or other “complete streets” projects
- Community and City Council office feedback regarding roadway conditions and priority street segments;
- Relative location of street segments to create multiple, continuous segments, consistency within neighborhoods, and project efficiency; and
- Multi-year geographic spread across the City and street network.

In 2021, DOT added equity as a criterion for zone selection. DOT staff cross-referenced the selected zones with census tracts designated by the Metropolitan Transportation Commission as “Equity Priority Communities” (EPC), formerly known as “Communities of Concern”, to better track equity in service delivery. Results confirmed that 313 out of 354 miles (roughly 88%) of local and neighborhood streets designated in EPC areas will be maintained by the end of the current three-year plan (2025). DOT anticipates completing pavement maintenance for nearly 76% of the local street network in this same timeframe.

DOT has maintained a total of 214 EPC miles since 2019 and will be maintaining an additional 22 EPC miles in 2023, which is about 14% of the 161 miles of Local and Neighborhood Streets selected for maintenance in 2023. This project includes seven EPC miles, which is about 14% of the anticipated 51 sealing miles.

The attachment to this memorandum contains the list of streets to be resurfaced (Refer to **Attachment – List of Streets**). The list may change if unforeseen circumstances arise or new information regarding other projects becomes available.

## **ANALYSIS**

Bids for the 2023 Local Streets Remove and Replace Pavement Project were opened on April 6, 2023, with the following results:

The responsive low bid submitted by O'Grady Paving, Inc. is \$3,833,200 and is 17% above the Engineer's Estimate. The higher-than-anticipated costs are attributable to the demand for paving contractors in the region. The Engineer's Estimate for this project is \$3,273,200. The estimate is based on bids received from similar past projects and current estimated construction prices. Radius Earthwork, Inc. did have the lowest bid for \$3,641,560. However, the contractor's Statement of Bidder's Experience did not meet the procurement requirements. The bid from O' Grady Paving, Inc., as the next responsive bidder, is considered acceptable for the work involved in the project. Staff recommends that the construction contract be awarded to O'Grady Paving, Inc.

O'Grady Paving, Inc. has previously completed multiple major paving project for the City of San José. In the 2022 construction season, O'Grady Paving, Inc. performed removal and replacement of asphalt pavement works on approximately 82 miles of City streets through two different major projects.

Construction is scheduled to begin in July 2023 and be completed by the end of September 2023.

## **Contingency**

San José Municipal Code Section 27.04.050 provides for a standard contingency of 10% on all public works contracts except those involving the renovation of building or buildings. The standard contingency is appropriate for this project

## **Project Labor Agreement Applicability**

The Project Labor Agreement is applicable to this project as the Engineer's Estimate is over \$1.2 million.

### **Local and Small Business Outreach**

Public Works procurement staff used Biddingo to outreach to local and small business enterprises. Chapter 4.12 of the San José Municipal Code defines a “local business enterprise” as one with a legitimate business presence in Santa Clara County and “small business enterprise” as a local business enterprise with 35 or fewer employees. Procurement staff sent bid invitations to 9,126 vendors, and documents were downloaded by 11 vendors, one of which was located within Santa Clara County. The recommended contractor is not a local or a small business enterprise. The listed subcontractor, Graham Contractors, is a local business from San José. Graham Contractors portion of work will be for crack filling, making up roughly 20% of the projects scope of work.

### **EVALUATION AND FOLLOW-UP**

DOT provides an ongoing evaluation of the City’s pavement conditions and provides periodic reports on this topic to the Transportation and Environmental Committee. In addition to the project discussed in this memorandum, three additional major street projects consisting of 75 miles and six additional local and neighborhood street pavement maintenance projects totaling 133 miles are scheduled for City Council action this spring.

### **COST SUMMARY/IMPLICATIONS**

This project supports the Transportation and Aviation Services City Service Area goal to *Preserve and Improve Transportation Assets and Facilities*. By performing pavement maintenance with this project, the extension of the useful life of the project streets will defer more costly reconstruction. The source of funding for this project is through the 465 – VTA Measure B 2016 Fund. This project will have no net operating and maintenance costs to the General Fund.
