

Quarterly Status Reports

Requirements:

- Property owner to submit Quarterly Status Reports on permitting and construction activities and vendor displacement, relocation, and termination
- Community and Economic Development Committee to review the owner's reports twice a year



Quarterly Status Reports

Report submitted in April 2023:

- Property owners will not provide the one-year notice of Flea Market closure prior to October 1, 2023 (instead of July 1, 2023)
- Application for Master Planned Development permit and Tentative Map under the City's review (*to be discussed at Berryessa Neighbor meeting on June 12*)

Vendor Outreach, Engagement, and Support

A new vendor support loan and technical assistance program led by local nonprofit organization, Mission Asset Fund (MAF) has been launched to assist Berryessa Flea Market vendors.

MAF will provide:

- a) Technical assistance
- b) Grants
- c) 0% Loans



Economic & Feasibility Studies

Estolano Advisors is conducting three inter-related studies:

- Economic and Cultural Impact Study
- Research on potential operating models
- Alternative site assessment



Advisory Group Timeline

March 28, 2023: staff shared the charter for the new Flea Market Advisory Group with City Council

April 25, 2023: Information Memorandum issued on completion of the member selection process and City Manager appointment (10 vendor representatives and one property owner representative)
