Approve the COVID-19 Recovery Task Force membership, as shown in Attachment A of the staff memorandum, as part of the FY 2021-2022 City Roadmap "Build Back Better + Recovery Task Force" Initiative. CEQA: Not a Project, File No. PP17-010, City Organizational and Administrative Activities resulting in no changes to the physical environment. (City Manager)

Public Comments: Tessa Woodmansee, Maria De Rueda; Dolores and Elmer (UA Local 19); Nick (Policy Director for Silicon Valley Council of Non-profits), Blair Beekman, Paul Soto, Brian Darby, Krista De La Torre (South Bay Labor Council) and Nora Morales provided comments.

Motion: Councilmember Raul Peralez moved his memorandum dated September 20, 2021 including Staff's recommendations and supplemental memorandum dated September 15, 2021 along with the inclusion of amendment to the membership to include organizations as listed below in "Action". Vice Mayor Chappie Jones seconded the motion.

Councilmember Magdalena Carrasco requested a friendly amendment to include Local 270. Vice Mayor Chappie Jones asked to include the Evergreen Islamic Center. The amendments were included.

Councilmember Sylvia Arenas asked about the inclusion of women. Rosalynn Hughey, Director, Planning, Building and Code Enforcement noted that a 'solution group' could be formed. Councilmember Sylvia Arenas asked specifically that a gender-based violence prevention agency, such as the YWCA be included. This motion was amended to include this agency.

Councilmember David Cohen requested the inclusion of an environmental issues group, such as the Sierra Club or Greenbelt Alliance. This modification was also accepted.

Mayor Sam Liccardo noted he could not support the motion on the floor, as recovery is many years in the making, and it is beyond the City's ability given the uncertainty and dynamic nature of pandemic and due to the lack of internal resources. He indicated that we will be returning in November to determine further budget issues.

Action: On a call for the question, the motion carried, and the COVID-19 Recovery Task Force membership was approved, including Councilmember Raul Peralez' memorandum dated September 20, 2021 to approve staff's recommendation including the supplemental memo dated September 15 and amending membership to include the following: "1. - Paul Soto spoke to the 'smoking mirror' theory and need to see ourselves reflected.
- Speaking to the effects of a homeless encampment in their neighborhood at Vista Montaña were Thomas Doherty, Alma, Hoda, Ofelia Hernandez, Raj, Srinath and Bharat. They complained that the City including their Councilmember David Cohen are not responsive to their plight, complaining of a creation of a toxic waste site, fire hazards and drug/alcohol use and endangerment of their children.
- Blair Beekman spoke on COVID testing and need for subsidy programs.
- Roland spoke on access to VTA meetings, indicating there should be an option to attend virtually. He also noted the violation of a federal code by not having closed captioning available.
