WHEREAS, Section 15.16.1410 of the San José Municipal Code requires the Director of Finance to file a report each year with the City Clerk, at least fifteen (15) days before the public hearing on the Storm Sewer Service Charge ("SSSC") assessments, and requires the City Clerk to cause notice of filing of the report issued by the Director of Finance regarding the imposition of annual SSSC, and the time and place of the public hearing; and

WHEREAS, City staff recommends that the filing date for the Director of Finance's annual report for Fiscal Year 2023-2024 SSSUC be moved from July 5, 2023 to July 14,
